

## **Briefing note for Scrutiny Panel**

### **North East Essex Health and Wellbeing Alliance Board**

#### **Background**

The North East Essex Health and Wellbeing Alliance (the Alliance) is a collaboration between commissioners and providers of North East Essex.

The Alliance has been established with the aim of transforming the health and wellbeing of the population of North East Essex by creating a sustainable system of health and wellbeing services that meet the immediate and longer-term needs of the population.

The North East Essex Alliance is one of three local delivery mechanisms for the North East Essex and Suffolk Sustainability and Transformation Partnership (STP). As part of Essex there are also strong ties with the public health, social care and wider economic development strategies of Essex County. The Alliance strategy is therefore designed to align with the STP's overarching goals, outcomes and governance structure, and with programmes that operate on an Essex wide geography, ensuring compatibility between delivery plans and a framework to ensure that decisions and programmes of work are interconnected with decisions and activity delegated to the most appropriate level.

#### **Agreed Outcomes**

This Alliance Board shall operate so as to enable the achievement of the following joint outcomes going forward:

- That people are resilient and able to help themselves and each other to keep healthy and well;
- That the most vulnerable will be supported - reducing the inequality of health and opportunity;
- That consistently excellent care for people when they need it, close to home and not just in a crisis is provided;
- That we make the best and most sustainable use of all available resources;
- That joined up care and support is coordinated around individuals and communities;
- That an integrated strategic “place-based” commissioning of health and care services is developed;
- That Commissioners work toward a single capitated budget.
