Reasons for the Decision

A procurement process was conducted under the EPH Framework Agreement Refuse Supplies – EPH21-002 – Lot 1 (Supply of plastic refuse/recycling sacks) for the supply of Refuse and Recycling Products. This ensures supply in accordance with the Council's Constitution.

Tender documents were issued based on the EPH framework agreement. Six suppliers submitted bids.

The bids were evaluated by a group of officers including the Senior Procurement Consultant, the Business Improvement Manager, and Systems & Data Officer and Business Development Officer from Neighbourhood Services. Scoring was based on the criteria and scoring mechanism detailed in the Invitation to Tender (ITT).

At initial assessment two out of six were completely compliant with the specification. The other four bids preliminary failed on sample sack dimensions. The four bidders were asked if they could meet the sack specification if chosen as preferred supplier. All four confirmed that they could meet our specification.

The lowest priced bidder compliant with all criteria, after sack dimension confirmation, Anzeck Plastics Ltd submitted two different price options. We were able to evaluate both sack options to secure a decision.

Anzeck Plastics UK source all their raw materials from UK suppliers (who also hold feedstock) and manufacture all their orders in their Bradford factory.

Alternative Options

There were alternative bidders that were able to meet the success criteria. The alternative bidders scored lower on the price evaluation criteria.
