Explanatory Note

We, the undersigned, request that the following decision be scrutinised by the Strategic Overview and Scrutiny Panel or Finance and Audit Scrutiny Panel as appropriate for the reasons set out below:-

The decision of the Portfolio Holder for Street and Waste Services on 1 August 2008, decision STS-001-008 Dedham Amenities.

Reason(s) for call in:

Duchy Field toilets are unable to cope with visitors, estimated at 60,000 per annum. These toilets are adequate for using the play areas and sports field. A new toilet would reduce the coach traffic using the High Street for the toilet amenity, thus removing a major traffic hazard.

There has been no consultation with the Council's partners Dedham Parish Council and the Dedham Vale and Stour Valley Partnership on the impact of reversing the decision to provide capital funding taken on 8th May 2008.

The proposed decision lacks transparency because it relies upon the ranking given to supporting tourism and public health within the new Administration's priorities. These priorities are unknown because they have yet to be published and will require debate and formal adoption before they can be used to justify any portfolio holder decision.

The portfolio holder has sought to reallocate an unspecified sum from an £800k capital investment in public conveniences an unspecified sum into other unspecified spending programmes. The original investment was authorised by full Council on the recommendation of Cabinet. Power to make this reallocation has not been delegated to the portfolio holder who has therefore sought to act beyond his powers. Furthermore, the failure to identify the sum involved and the destination programmes will make tracking expenditure against budgets in those areas impossible.

This report concerns the provision of public toilets in Dedham

1. Decision(s) Required

1.1 To withhold the capital funding for the new build of additional public toilets in Mill Road Car Park, Dedham.

2. Reasons for Decision(s)

2.1 Dedham village currently has public toilets on the Duchy Field which are managed by Colchester Borough Council. There is currently no survey or usage statistical evidence other than public opinion to justify the need for additional toilets to be located in the Mill Road Car Park serving visitors as they arrive in the village, particularly in view of the administrations revised priorities for capital spend.

3. Alternative Options

3.1 To pursue the build of additional public toilets in Mill Road car park.

4. Supporting Information

- 4.1 The new administration has highlighted priorities for capital investment. At this time the new build of additional toilet facilities in Dedham is not considered of a high enough priority given the current provision of similar facilities in the village.
- 4.2 The Councils toilet strategy outlines the existing toilets on the Duchy Field as a priority for refurbishment. This refurbishment will go ahead and is currently subject to a feasibility study in order to ascertain indicative costs.
- 4.3 The Dedham toilets on the Duchy Field have been included as part of the Creative Conveniences project and artists have been commissioned to design elements of this work.
- 4.4 In recent years Colchester Borough Council have financially supported the use of portable toilets in Mill Lane car park at periods of high demand such as bank holidays. It is anticipated that this funding arrangement will continue for the periods of high demand only.

5. Proposals

5.1 The provision of additional public toilets at Mill Road Car Park, Dedham is not supported by funding allocated from the Council's Capital Programme.

6. Strategic Plan References

6.1 There are no specific Strategic Plan references.

7. Consultation

- 7.1 Extensive consultation has taken place and will continue as proposals are developed to refurbish the existing facilities on the Duchy field.
- 7.2 Dedham Parish Council carried out consultation with residents and local businesses. It was the opinion of the Parish Council, when presented to officers, that additional toilet facilities in Mill Road car park were required.

8. Publicity Considerations

8.1 This is a high profile project for the area and as such the commitment to review the level of investment is likely to generate media coverage. Accordingly a media statement will be produced to provide appropriate information to encourage accurate reporting.

9. Financial implications

- 9.1 Cabinet has released £300,000 from the capital programme to implement the next phase of the toilet strategy. Following refurbishment of the existing toilets the remaining capital will be re-allocated to other priorities in the Councils Capital D programmes.
- 9.2 The remaining Capital will be used to meet funding gaps identified in various capital projects since 1st May 2008, as outlined in section 7.1 of the report to cabinet dated 9 July 2008, 2009/10 Budget Strategy, Medium term Financial Forecast and Budget Timetable.
- 9.2 Dedham toilets at Duchy Field have been included as part of the Creative Conveniences project. Funding has been secured for commissioning artists to interpret the surrounding area in a variety of media in the toilets.

10. Equality, Diversity and Human Rights implications

10.1 There are no particular equality, diversity or human rights implications in taking this decision. Toilets specifically designed for disabled use are provided in the existing toilets on the Duchy field.
