4. Details of association of the above premises with serious crime, serious disorder or both: [Please read guidance note 2]

Between 29th June 2021 and December 2021 Essex Police has undertaken an operation to disrupt the supply of Class A drugs (including cocaine) in and around The LEATHER BOTTLE, SHRUB END ROAD, COLCHESTER. This operation has three phases:

<u>Phase 1</u> being the use of undercover officers to observe and detect drug dealing between July 2021 and November 2021.

Phase 2 the working up of intelligence and evidence.

<u>Phase 3</u> the arrest of suspects, the execution of warrants and the further investigation of offences disclosed. Phase 3 began on the 09/12/2021 and is continuing.

During phase 1 of the operation undercover officers were deployed to The Leather Bottle, Shrub End Road, Colchester on selective dates. On those occasions the open use of cocaine within the premises was observed and drug dealers routinely sold cocaine on the premises, including to undercover officers.

Where a drug supply offence is selling directly to users (as is this case) - the UK Sentencing Council categorises this as 'Category 3' for the purposes of sentencing, the starting point for those with a lesser role is 3 years imprisonment and for those with a leading role 8 years 6 months imprisonment. These therefore are 'serious crimes' as set out within section 53A(4) of the Licensing Act 2003 which states a 'serious crime' has the same meaning as in the Regulation of Investigatory Powers Act 2000 (s81(2) and (3) and which defines a serious crime as one where a person who has attained the age of twenty-one and has no previous convictions could reasonably be expected to be sentenced to imprisonment for a term of three years or more (...) or includes the use of violence etc.. In accordance with Regulation 18 of the Licensing Act 2003 (Hearings) Regulations 2003, will ahead of the hearing provide documentary information in support of this application and to expand upon the details set out below.

- 25th June 2021 Undercover Police officers attended the premises where they enquired about buying cocaine. The officer was directed to the gent's toilets with the suspect where he divided the cocaine into bags. On this occasion the officer was supplied with 3 x bags of cocaine. The officer formed the opinion that the DPS was fully aware of what was going on.
- On 29th June 2021 an undercover officer attended the premises and witnessed several people openly smoking cannabis in the garden area. The undercover officer witnessed a customer openly discussing drugs while on his mobile phone. Officers also noted pairs of males sharing toilet cubicles and visibly tidying their noses as they left, indicating cocaine use.
- **On 7th July 2021** -Undercover officer witnessed a fight at the premises involving 8 males using weapons which escalated into 3 members of the fighting driving at people in the car park. (ATHENA REFERENCE or not reported to Police)
- On 17th July 2021 –Undercover Police officers while in the beer garden were offered to purchase class A drugs by a female customer. This female facilitated the sale by a male in her party who sold the police officers cocaine.
- On 22nd July 2021 Undercover officers attended the Leather Bottle, the officers made telephone contact with the male who previously supplied them with drugs. This male made arrangements to meet the officers outside the pub where he supplied one bag of cocaine.
- On 29th July 2021 Undercover officers attended the Leather Bottle, the officers made telephone contact with the male who previously supplied them with drugs. This male made arrangements to meet the officers outside the pub where he supplied one bag of cocaine. This suspect was then joined by another male from inside the premises, the undercover officers noted that these males acknowledged each other and that a drug deal was taking place the male from within the premises referred to the suspect "he's my boy"

13th August 2021 - Undercover officer while sitting at the bar area was offered cocaine for sale. The sale of 2 x bags of cocaine was made in the beer garden. The undercover officers reported that this male was well known to the DPS, staff & customers alike.

20th August 2021 -The Undercover Police officer attended the Leather bottle pub where he sat with the 2 males that had previously sold him drugs on 29th July and the DPS Sally. It was clear to the officer that all parties were well known to each other.

27th **August 2021** - Undercover officers evidence attending the premises and being recognised by the suspect who had previously supplied them with cocaine on 13th August 2021. This male offered the officers 3 bags of cocaine for £100. Officers accepted, paid the cash, the suspect then attended another table where he was given a set of car keys by another male. Within 5 minutes the male returned where he supplied officers with 3 bags of cocaine.

On 10th September 2021 - Undercover officers attended the premises where they were offered cocaine by a previous suspect. On this occasion they did not purchase any drugs.

On 12th October 2021 - Undercover police officers while at the premises were again offered cocaine for sale. They declined on this occasion, but did report see this suspect deal drugs to customers near the door. Officers noted that during the deployments taking & supplying appeared to be accepted and known by staff & DPS.

It is Essex Police belief is that the use of cocaine was so blatant and conducted in plain sight that management and staff were either complicit or were wilfully blind to the occurrences. The drug dealing was widespread (it took place on each occasion the premises were visited) and conducted in the open.

At the full hearing Essex Police will be requesting the authority to revoke the premises Licence.

Essex Police consider it absolutely essential to break the offending cycle by immediately closing the premises thus affecting the current customer base and excluding drug dealers. This will have a powerful deterrent effect on other premises where drug dealing is an issue. It will facilitate the current premises licence holder in taking steps to consider how best to prevent a reoccurrence should at a hearing the licence is not revoked – this would provide time to reflect on the staff currently employed, their training and relevant procedures with a view to implanting changes should the licence not be revoked at a hearing. These changes, if the licence is not revoked, would need to include CCTV provision and use of door supervisors.

Essex Police has submitted a summary review application for the reason that immediate suspension of the licence is required – no other interim steps would achieve the objective of preventing the distribution of drugs from this premises.

Essex Police requests that as 'interim steps' the licence is suspended until the full hearing takes place.

Given the nature of the incidents and the use of undercover officers and that these are live criminal convictions, Essex Police asks that in accordance with Regulation 14 of the (Hearing) Regulations that the public are excluded from those parts of the hearing where the specifics of the drug dealing are mentioned and that these are not published in open forum.
