At a meeting of the Licensing Sub-Committee held on 10 April at 10.00am in the Council Chamber, Colchester Borough Council, Town Hall, High Street, Colchester

1. Membership

RESOLVED that Councillor Dundas be appointed Chairman.

2. Minutes of Previous Meeting

RESOLVED that the minutes of the hearings held on 30 November and 7 December 2018 be approved as a correct record.

3. Licensing Application

The Assistant Director, Communities, submitted a report in relation to the following premises.

• Charter Hall, Cowdray Avenue, Colchester

In Attendance

James Young, Events Manager for Amphora Trading Ltd - Applicant Georgia Tamblyn, Colchester Civic Society - Objector Rebekah Straughan, Legal Services Jon Ruder, Licensing, Food & Safety Manager Zoe Gentry, Democratic Services Officer

Mr Ruder outlined the application to which an objection had been lodged by Mrs Tamblyn, on behalf of the Colchester Civic Society. The application sought a licence in the name of Colchester Amphora Trading Ltd for Charter Hall, Colchester. The premises already had the benefit of a licence held by Colchester Borough Council. There had been no responsible authority representations to the application.

Mr Young gave a brief introduction to the application explaining that the application had been made to enable events to be operated under the banner of Amphora Trading but it was not anticipated that there would be a substantial change in the type of events that were offered to those that had been run under the existing Charter Hall Leisure World licence, for which Mr Young was the Designated Premises Supervisor.

The application had sought a slight increase in the hours for the sale of alcohol, late night refreshment and overall opening relative to the licence currently in place. Mr Young also requested off sales to enable alcohol to be purchased at events such as Gin Fayres, and taken home for consumption.

Mrs Tamblyn then addressed the Sub-Committee explaining that she was there to represent the Colchester Civic Society and to speak on behalf of its members. Mrs Tamblyn gave further details in relation to her objection which centred on the Council's current Statement of Licensing Policy.

RESOLVED - to grant the application as follows and subject to the conditions as set out in the operating schedule of the application -

- A) The sale of alcohol on the premises Mondays to Thursdays from 06.00 to 02.00, Friday and Saturdays from 06.00 to 03.00 and Sundays from 06.00 to 02.00; and the sale of alcohol off the premises from 09.00 to 20.00 Mondays to Sundays inclusive.
- B) The performance of plays, provision of films, indoor sporting events, live and recorded music and performances of dance indoors Mondays to Thursdays from 06.00 to 02.00, Friday and Saturdays from 06.00 to 03.00 and Sundays from 06.00 to 02.00
- C) The provision of late night refreshments Mondays to Thursdays from 23.00 to 02.00, Friday and Saturdays from 23.00 to 03.00 and Sundays from 23.00 to 02.00


Reasons for the determination

In arriving at the decision the Sub-Committee considered each point very carefully. It noted the representations and the evidence presented by the applicant and Mrs Tamblyn from the Colchester Civic Society.

The Sub-Committee carefully considered the representation made by Mrs Tamblyn regarding its 2016 statement of licensing policy and that it should take precedence. the Sub-Committee noted that none of the responsible authorities had made any representations regarding this application. Furthermore the existing premises licence had not been the subject of a call for a review by any of the responsible authorities or members of the public and it noted that the existing premises licence has been operating satisfactorily.

With regard to sale of alcohol off the premises the Sub-Committee did not consider that the case was proved sufficiently to justify granting off sales as applied for in the application and therefore determined to restrict the hours for off sales to 09.00 to 20.00 Mondays to Sundays.

2. Conditions

Suggested conditions

The following conditions, based on the operating schedule, are suggested.

- 1. No super-strength beer, lagers or ciders of 6.5% ABV (alcohol by volume) or above shall be sold at the premises.
- 2.Documented records of training completed shall be kept for each member of staff. Training shall be regularly refreshed and at no greater than 12 monthly intervals. Training records must be made available for inspection upon request by a Police officer or an authorised officer of Colchester Borough Council.
- 3. The Challenge 25 scheme must be operated to ensure that any person who appears to be under the age of 25 shall provide documented proof that he/she is over 18 years of age. Proof of age shall only comprise a passport, photo card driving licence, an HM Forces warrant card, or a card bearing the PASS hologram.
- 4. The premises must install, operate and maintain a comprehensive digital CCTV system. All public areas of the licensed premises, including all public entry and exit points, and the outside area must be covered, enabling facial identification of every person entering in any light condition. The CCTV cameras must continually record while the premises are open to the public and recording must be kept available and unedited for a minimum of 31 days with the date and time stamping. Any footage must be in a format that can be played back on a standard personal computer or standard DVD player. Where the recording is on a removable medium (i.e. compact disc, flash card etc.), a secure storage system to store those recording mediums must be provided.
- 5. Staff must regularly supervise the outside area and ensure that customers do not cause a public nuisance.
- 6. The premises must close when the Park closes.

4. Policy Context

Policy references are given for guidance only, they should not be regarded as a substitute for the Policy which contains the necessary detail for all parties in making and determining applications

2.2 The aims of this Licensing Policy are to pursue and promote the licensing objectives by encouraging:

- Desirable destinations for a wide range of age groups
- Licensed premises suitable for the area within which they are located
- Diversity of entertainment throughout the town centre that appeals to a wider audience
- A wide range of uses of premises
- 2.9 Applicants are expected to consider all the matters relevant to their application; these include key factors and where appropriate special guidance in relation to the Town Centre Zone.
- 2.11 If there is a relevant representation, the application will be considered against the guidance contained within the policy and steps taken which are appropriate and proportionate to promote the licensing objectives.
- 2.14 In considering conditions to be attached to licences and certificates, the Licensing Authority will ensure that conditions must:
 - be specific for the premises;
 - not duplicate existing provisions;
 - be capable of being met;
 - be appropriate and proportionate for the promotion of the licensing objectives: and
 - be tailored to the individual style and characteristics of the premises and events concerned.
- 2.15 It is acknowledged that conditions can only be imposed that seek to manage the behaviour of customers when they are on the premises and within the control of the licensee or in the immediate vicinity of the premises.
- 2.17 Licensing law is not the primary mechanism for the general control of nuisance and antisocial behaviour by individuals once they are away from the licensed premises and, therefore, beyond the direct control of the individual, club or business holding the licence, certificate or authorisation concerned. Nonetheless, it is a key aspect of such control, and licensing law will always be part of a holistic approach to the management of the evening and night time economy in the Borough.

3 Key Factors

- 3.1 The key factors set out in the Policy are intended to address the principle issues related to licensed premises. Licensed premises and activities can play an important role in ensuring that the Borough is vibrant, prosperous, thriving and welcoming. However, if premises are not managed responsibly they can also impact negatively on an area by causing a wide variety of problems.
- 3.2 Our aim is to promote an 'inclusive' evening and night time economy throughout the Borough to ensure people of all ages can participate in and enjoy a range of activities. These Key Factors are designed to ensure that all licensed premises throughout the Borough operate to promote the four licensing objectives in order to ensure they contribute positively to the Borough. The Key Factors are:
 - KF1 What we aim to encourage
 - KF2 The location of licensed premises

- KF3 Hours for licensed premises
- KF4 Standards to promote the licensing objectives
- KF5 Off sales of alcohol

KF1 - What we aim to encourage

3.13 The aim is to ensure desirable destinations that cater to a wide range of age groups and uses. Premises that are encouraged are:

Those that will extend the diversity of entertainment and attract a wider range of participants and in particular venues that offer diversity within the night time economy such as late night cinema, without the sale of alcohol, and live music venues. Venues that offer original material, are encouraged particularly to provide a range of live performances and styles of music, provided that such entertainment does not undermine the licensing objectives.

Family friendly venues, where people with children can attend, are encouraged.

Restaurants and Cafés as well as other less alcohol-dominated venues.

3.14 Subject to compliance with the other policies the types of licensed premises set out in the Matrix below will generally be considered acceptable, unless relevant representations are made and/or the Licensing Authority considers that the application will undermine the licensing objectives. The Council wishes to see wider diversity in the night time economy and in particular wishes to encourage premises whose primary purpose is not the sale of alcohol.

KF2 - The location of licensed premises

- 3.15 The Licensing Authority considers the following as key issues in relation to the location of licensed premises:
 - The proposed operation of the premises having regard: to the licensable activities applied for, the size, structure and proposed capacity, the type/nature of the business

- The proximity of the premises to local residents.
- The proximity of the premises to other local businesses that could be affected
- The general character of the surrounding area including crime and antisocial behaviour levels
- The availability of transport to and from the premises

KF3 - Hours for licensed premises

- 3.20 The Licensing Authority considers that measures must be taken to address the causes of crime and disorder and public nuisance linked to the night time economy.
- 3.22 The Licensing Authority will have particular consideration to the location of premises and their likely effect on the locality when considering whether the hours requested are appropriate to the area and consistent with promoting the four licensing objectives (see the Matrix in paragraph 3.14). Opening hours will not generally be regulated but each application will be considered on its own merits and in particularly noise sensitive locations it may be appropriate to consider the opening hours of a premises.
- 3.23 Where relevant representations are made, premises that are considered to meet the criteria 'What we aim to encourage' will normally be given greater freedom to operate than premises that could be considered more likely to have a detrimental impact upon the licensing objectives, such as youth-oriented, alcohol- driven premises.
- 3.24 It is expected that hours for licensed premises will be particularly relevant having consideration to the location of the premises. Consequently, the hours applied for licensable activities should be appropriate with regard to the nature of the location of the premises. It is recognized that in spite of the quality of the operation of the business, where patrons are out of the control of the licensee, the lateness of the terminal hour for the premises will often be a contributory factor in the potential for disturbance.

KF5 Off-sales of alcohol

- 3.34 The Council has implemented a Public Space Protection Order for the town centre in order to address and prevent numerous problems caused by public consumption of alcohol. Street drinking can be a major cause of antisocial behaviour, often involving underage persons, which gives rise to disorder, concerns over public safety and harm to children. Additionally it is widely reported that consumption of alcohol by persons on the way to on-licensed premises gives rise to problems of drunken and disorderly behaviour.
- 3.35 In the light of the above therefore applicants are expected to demonstrate that there will be no derogation in the licensing objectives and that the operation of the premises will support the Key Factors. The Licensing Authority will give particular consideration to the hours requested for sales of alcohol. Persons who are alcohol-dependent may be drawn to particular premises if there are licensed to sell alcohol at earlier times that other premises. Additionally, if there are issues related to late night

disorder, the hours for alcohol sales from the premises may be restricted.

9. Town Centre Zone

- 9.3 There is evidence of problems associated with operation of licensed premises in the Town Centre Zone and the Licensing Authority wishes to see a decrease in the levels of crime and disorder and public nuisance already being experienced in the area. However, the authority does wish to diversify the evening and night time economy in in this area.
- 9.5 With this in mind, and subject to compliance with the other requirements of the policy (in particular paragraph 3.14), the following guidance for new licences and material variations, where relevant representations have been made, is offered:
 - a. The following venue types are strongly encouraged provided they do not undermine the licensing objectives and therefore the licensing policy:
 - Restaurant
 - Non-alcohol led premises
 - Live entertainment venue
 - Coffee shops

Please note

• In the case of premises which encompass two or more uses it is incumbent on the applicant to state the primary use of the premises; this use must be supported by the management plan/operating schedule.

5. Background Information

Information relevant to the licensing and/or operation of the premises

The premises is located within the Castle Park and the operational times of the premises are tied to the opening and closing hours of the Castle Park. They are therefore subject to seasonal variation.

6. Options available to the Sub-Committee

The Sub-Committee must take such of the following steps as it considers appropriate to ensure the promotion of the licensing objectives –

- Grant the application as requested
- Grant the application whilst imposing additional conditions
- Exclude or reduce the hours of operation of any licensable activities included within the application
- Reject the whole or part of the application





I welcome the changes in this Licence Application from the previous submission. However, they do not affect the objections I have. In particular the reduction in hours proposed would not prevent applications for temporary extensions when the Upper Park is open after permitted hours such as the Summer Concerts and the Fireworks Display.

The application puts at risk the peace of our award winning Park, possibly endangering the green flag it has been awarded for a number of years.

It would have a deliterious effect on the lives of the residents of Wakefield Close, most of whom are over 65. There is protection against such development at every other place in the area.

It would the enjoyment of the new facilities by children when people attend solely to consume alcohol and not to use the Crazy Golf.

Colchester's Licensing Policy refers to cultivating our green spaces for health, wellbeing and the enjoyment of all and to premises contributing positively to the area in which they are situated. Clearly they are not fulfilled here.

Key Factor 2 stresses the need for premises to be ine right places. I believe this is notin the right place. Key Factor 3 talks about the location of the premises affecting the locality and about noise sensitive locations. Wakefield Close has green spaces on both sides which are protected from development. This application would cause noisy and unruly behaviour is a quiet, residential area.

Reference is made in the Licensing Policy to the availability of public transport. The nearest public transport is High Street and North Station Road, both at some distance via ill lit paths.

The sale of alcohol is likely to take place during the hours when the park is open for special events. Users would be both those attending the event and those who watch the fireworks from outside the houses and behind the houses in Wakefild Close. These people would have difficulty in the dark. At presentno trouble is encountered but consumption of alcohol is likely to have an effect.

In my view the Council's policy objectives of prevention of public nuisance, publicsafety and the protection of children would be breached by this application.

Application for an alcohol licence for Putt in the Park. I wish to object to this application on the following grounds:

I believe that this application is wholly inappropriate for the venue and location for the following reasons.

- 1. A small family type entertainment that normally attracts young families as well as older participants is much more suited to the cafe facilities already applied for and granted.
- 2. There are many more local hostelries already serving alcohol.
- 3. When young children are involved in activities their safety must first and foremost be considered and, as a sporting person myself, I know full well that the consumption of alcohol does not go well with any physical activity, however 'gentle' it may appear.
- 4. The granting of an alcohol licence will also make the venue an attraction for Corporate and Group functions which would be totally out of character for the location. Indeed the website for the London Putt in the Park venues promotes "office tournaments, corporate events and parties" all year round.
- 5. The venue is very close to residential properties, in fact it is just a footpath away from the closest, and will already affect the residents with noise and light pollution.
- 6. It is inevitable that if this licence is granted the holder will use best endeavours to promote the sale of alcohol since that is where the greatest potential lies for profit; and profit is the aim of any business.
- 7. The opening hours for the current 'Putt in the Park' venues are all 9.00am to 9.00pm with food and golf finishing at 8.00pm and the bar remaining open until 9.00pm all year round. It would seem eminently logical that the intention of the applicant is for Colchester 'Putt in the Park' to follow suit.
- 8. I believe that the Council's objectives of the 'prevention of public nuisance; public safety and the protection of children from harm' would be breached by this application.



We, the undersigned residents at nos 88, 90 and 92 Roman Road, Colchester, wish to express our strong objection to this application for a premises license to sell alcohol at what will be this 'Putt in the Park' venue in the former upper bowling green in Castle Park.

Our houses are within about 100 metres of this venue, and we are concerned that the proposed sale of alcohol from 8am until 9pm / seven days a week, as the application apparently states, could represent a significant change to the character of this quiet and peaceful part of the town centre.

We do not see any need at all to sell alcohol at such a venue. The 'Putt in the Park' company's website (www.puttinthepark.com) clearly shows that its other venues in London are not just about 'golf-putting', as we innocently assumed, but are being marketed as party venues for corporate functions as well as weddings and private parties. This will not just be a daytime activity for children and families in warmer months of the year but the clear boast of a "floodlit" course indicates that a substantial part of the activities will be these parties.

The sale of alcohol is clearly integral to the proposed operations of Putt in the Park. We recognise that not all alcohol consumption leads to public displays of anti-social behaviour, but already there are often problems with excessive alcohol consumption in the town centre, and Roman and Castle Roads see the unfortunate effects and results of this on regular occasions. This is also increasingly the case with the evergreater number of ticketed private events taking place in what is a public park, when the park is closed off to all but ticket holders (an aberration of the very definition of a "public park" anyway). Such events frequently lead to an increase in litter in the

surrounding area (which no-one, it seems, bears any responsibility for clearing up except local residents themselves), and sometimes argument and disturbances obviously fuelled by excessive alcohol consumption.

obviously fuelled by excessive alcohol consumption.

There will also be great pressure on the availability of public parking close to this former bowling green. There is no parking immediately nearby, and we are concerned that party events in the evenings and on Sundays – which is most probably when they will take place and for when the alcohol license will be required, and which happens to be when the residents parking permissions are not in force – will lead to an increase in Putt in the Park customers looking to park their cars in Roman and Castle Road. The company's website says it can cater for parties of between 10 and 70 people. This could significantly contribute to what is already intense pressue on available parking spaces most of the time in these two roads.

Although it is too late to object to the Putt in the Park development even going ahead – which we would have done had we been aware of it – we wish to strongly oppose this application for an alcohol license on the grounds that it is unnecessary and will be a contributory factor to greatly increased noise, light pollution, litter, traffic issues, and potential anti-social behaviour. It could distinctly change the character of the area, which is why many of the residents live in Roman and Castle Roads, and the nearby Riverside area of housing, and have done for many years, and what attracts new residents.

We hope due consideration will be given to our objection,
