At a meeting of the Licensing Sub-Committee held on 10 April at 10.00am in the Council Chamber, Colchester Borough Council, Town Hall, High Street, Colchester

Present: - Councillor Buston Councillor Chuah Councillor Hogg

1. Membership

RESOLVED that Councillor Buston be appointed Chairman.

2. Minutes of Previous Meeting

RESOLVED that the minutes of the hearings held on 10 April be approved as a correct record.

3. Licensing Application

The Assistant Director, Communities, submitted a report in relation to the following premises.

• Putt in the Park, Castle Park

In Attendance

David Beamish - Applicant Giovanna Apporthiniari, Colin Butterfield and Alderman Henry Spyvee- Objectors Rebekah Straughan, Legal Services Sarah White, Licensing Officer Zoe Gentry, Democratic Services Officer

Mrs White outlined the application in respect of Putt in the Park to which objections had been lodged by a number of residents; a representation in support of the application had also been submitted. There had been no responsible authority representations to the application.

Mr Beamish outlined the application explaining that he already operated three pitch and putt courses in London which were fully licensed; Colchester would be their first venue outside London. They operated the same formula at each venue, providing a pitch and putt course with a licensed café. Experience gained from operating the London venues indicated that people did not want to remain after the park was shut and therefore, they proposed closing in line with the Park closing times. Whilst the London establishments had later opening hours and could be hired for private parties, Mr Beamish explained that the location and size of the café meant that it was unlikely to be an attractive venue for private parties although children's parties may be held there. The objectors addressed the Sub-Committee on the points made in their letters. A number of concerns were raised including concerns in relation to the hours of opening, noise, parking, disruption to wildlife, the Green Flag status of the Park, and whether there was a need to sell alcohol. In response to objectors concerns Mr Beamish reiterated that the hours of business would match those of the Park. Mention had been made by the objectors and the Sub-Committee of the arrangements for those nights when the Park was open late for events such as the fireworks and Mr Beamish responded that on such nights they would not open late to avoid the premises being used as a short cut to gain entrance to the Park. This matter, along with some other matters of concern such as opening times, would be controlled by the lease between the applicant and Colchester Borough Council.


RESOLVED that the application be granted.


Reasons for the determination

In arriving at the decision, the Sub-Committee considered each point very carefully. It noted the representations and the evidence presented by the applicant and the objectors. It was noted that some of the points raised, including parking, the need for the premises and concerns for wildlife, were not within the remit of the Licensing Act 2003 and therefore could not be considered by the Sub-Committee.

The Sub-Committee considered the application and the representations made. It noted that the applicant had volunteered and undertaken that the premises would not be open for the sale of alcohol other than when the park was open or within the times as set out within the application (whichever time of closing shall be earlier); suitable steps would be taken to ensure that no alcoholic drinks were taken off the premises; background music internal to the café / clubhouse only would be played; and that there was no intention to apply for any further or late licences. In the light of the above the Sub-Committee determined to grant the application as applied for subject to the conditions set out.

	The external bar shall be located on the nort of the beer garden bar entrance.				

Local Residents	We object to this proposal.
	We live in St John's Close some 400 metres from the Rovers Tye (as the crow flies).
	Very occasionally there is an outdoor event with music and sometimes smells of cooking which are quite apparent even at this distance. It is not too bad a problem as things usually quieten down by 10pm.
	If, however, an outside bar leads to this sort of thing or to an increase in noise from customers on most fine evenings, it would be very disturbing - perhaps until closing time.
	Any such activity would be so much worse for those living nearby, of course.
	We hope that you will refuse this application for the benefit of local residents.
	The three Highwoods Ward Councillors object to the application to install an outside bar. The location is approximately 20' from the nearest residential property.
	We get complaints regularly from residents some of whom have already written in. The application is likely to increase crime and disorder, noise and public nuisance.
	Beverley and I have witnessed shouting, noise, and disorder even the picket fence has been kicked out and had to be repaired on a number of occasions.
	I have to say residents have commented that sometimes walking past this garden area when it's at it's worse can be intimidating and they fear adding a bar outside is likely to increase alcohol intake and public nuisance.
	Dear Sir or Madam
	In reference to plans to have an outside bar aat the Rovers Tye public House Highwoods.
	Being a resident close to the pub I don't like it being close to my back garden.
	We already have to put up with the occasional glass or bottle being put on the wall or thrown into the garden.
	I would like to register my disapproval of the plans for a bar being approved by the Council.

4. Policy Context

Policy references are given for guidance only, they should not be regarded as a substitute for the Policy which contains the necessary detail for all parties in making and determining applications

2.2 The aims of this Licensing Policy are to pursue and promote the licensing objectives by encouraging:

- Desirable destinations for a wide range of age groups
- Licensed premises suitable for the area within which they are located
- Diversity of entertainment throughout the town centre that appeals to a wider audience
- A wide range of uses of premises

2.9 Applicants are expected to consider all the policies relevant to their application; these include general policies, key factors and where appropriate special policies.

2.11 If there is a relevant representation, the application will be considered against the guidance contained within the policy and steps taken which are appropriate and proportionate to promote the licensing objectives.

2.14 In considering conditions to be attached to licences and certificates, the Licensing Authority will ensure that conditions must: \cdot be specific for the premises; \cdot not duplicate existing provisions; \cdot be capable of being met; \cdot be appropriate and proportionate for the promotion of the licensing objectives: and \cdot be tailored to the individual style and characteristics of the premises and events concerned.

2.15 It is acknowledged that conditions can only be imposed that seek to manage the behaviour of customers when they are on the premises and within the control of the licensee or in the immediate vicinity of the premises.

2.17 Licensing law is not the primary mechanism for the general control of nuisance and antisocial behaviour by individuals once they are away from the licensed premises and, therefore, beyond the direct control of the individual, club or business holding the licence, certificate or authorisation concerned. Nonetheless, it is a key aspect of such control, and licensing law will always be part of a holistic approach to the management of the evening and night time economy in the Borough.

3 Key Factors

3.1 The key factors set out in the Policy are intended to address the principle issues related to licensed premises. Licensed premises and activities can play an important role in ensuring that the Borough is vibrant, prosperous, thriving and welcoming. However, if premises are not managed responsibly they can also impact negatively on an area by causing a wide variety of problems.

3.2 Our aim is to promote an 'inclusive' evening and night time economy throughout the Borough to ensure people of all ages can participate in and enjoy a range of activities. These Key Factors are designed to ensure that all licensed premises throughout the Borough operate to promote the four licensing objectives in order to ensure they contribute positively to the Borough. The Key Factors are:

KF1 What we aim to encourage

KF2 The location of licensed premises

KF3 Hours for licensed premises

KF4 Standards to promote the licensing objectives

KF5 Off sales of alcohol

KF2 - The location of licensed premises

3.15 The Licensing Authority considers the following as key issues in relation to the location of licensed premises:

- The proposed operation of the premises having regard: to the licensable activities applied for, the size, structure and proposed capacity, the type/nature of the business.
- The proximity of the premises to local residents.
- The proximity of the premises to other local businesses that could be affected.
- The general character of the surrounding area including crime and antisocial behaviour levels.
- The availability of transport to and from the premises.

4. Background Information

Information relevant to the licensing and/or operation of the premises

The Rovers Tye already has a premises licence in operation (see Appendix 3). The proposed variation is to vary the licensing plan to include the external areas incorporating an external bar for the sale and consumption of alcohol. No other changes to the licence are proposed.

5. Options available to the Sub-Committee

The Sub-Committee must take such of the following steps as it considers appropriate to ensure the promotion of the licensing objectives –

- Grant the application as requested
- Grant the application whilst imposing additional conditions
- Exclude or reduce the hours of operation of any licensable activities included within the application





Annex 1 – Mandatory Conditions

All supplies of alcohol

1. No sale/supply of alcohol shall be made under the premises licence-

- a. At a time when there is no designated premises supervisor in respect of the premises licence; or
- b. At a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

2. Every supply of alcohol under the premises licence must be made, or authorised by a person who holds a personal licence.

Drinks promotions

3(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

3(2) In this paragraph, an irresponsible promotion means one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.

a. games or other activities which require or encourage, or are designed to require or encourage, individuals to –

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

- b. provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- c. provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- d. selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- e. dispensing alcohol directly by one person into the mouth of another (other than where that person is unable to drink without assistance by reason of a disability).

Provision of water

4. The responsible person must ensure that free portable water is provided on request to customers where it is reasonably available.

Age verification policy

5(1) The premises licence holder or club premises certificate holder must ensure that the an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

5(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

5(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-

- a. a holographic mark; or
- b. an ultraviolet feature.

Alcoholic drink measures

6. The responsible person must ensure that-

- a. where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures–
 - (i) beer or cider: $\frac{1}{2}$ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
- b. these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c. where a customer does not in relation to the sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available

Minimum Drinks Pricing

7(1). A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

- 7(2) For the purposes of the condition set out in paragraph (1)
 - a. "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - b. "permitted price" is the price found by applying the formula-
 - . P=D+(DxV)

Where -

- (i) P is the permitted price
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of alcohol;
- c. "relevant person" means, in relation to premises in respect of which there is in force a premises licence
 - (i) The holder of the premises licence
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d. "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the members or officer to prevent the supply in question; and
- e. "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

7(3) Where the permitted price given by Paragraph (b) of paragraph 2would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- 7(4)(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) or paragraph 2 on a day ("the first day") would be different from the permitted price on the next day (2the second day") as a result of a change to the rate of duty or value added tax.
- 7(4)(2) The permitted price which would apply on the first day applied to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Door supervision

8. Where a premises licence includes a condition that at specified times one or more individuals must be present at the premises to carry out security activity, they must be licensed by the Security Industry Authority. 9(1). Any exhibition of films must be screened in accordance with the category issued by the British Board of Film Classification (BBFC) certification.

9(2). Admission of persons under the age of 18 shall be restricted in accordance with any recommendation made by the above film classification body and any guidance issued under the licensing authority's Statement of Licensing Policy.
