#### 5. Minutes

RESOLVED that the minutes of the meeting held on 20 June 2018 were confirmed as a correct record.

#### 6. Public Ideas

#### Victoria Weaver

Victoria Weavers attended the meeting to suggest that a report on unitary authorities be included on the work programme of the Policy and Public Initiatives Panel.

Victoria Weavers suggested that this issue was included in the Labour party manifesto and would bring Colchester closer to the community. Victoria Weavers stated that Colchester was different to the rest of Essex and that being separate from the County Council would be a benefit. The report could summarise the pros and cons of becoming a unitary authority.

#### **Panel Discussion**

Members of the Panel welcomed the suggestion to look at the pros and cons of unitary authorities as part of the Work Programme. Members suggested that this could include information regarding current examples of unitary authorities in Essex, such as Southend and Thurrock. Further comments were made regarding how a unitary authority would simplify the structure of local government for members of the public. Panel members also highlighted that whilst, not necessary at this stage, if it were to proceed further the views of members of the public would need to be considered.

A member of the Panel questioned how this issue would be placed on the Government agenda if it were to go ahead and what size the unitary authority would be.

#### Victoria Weaver

In response, Victoria Weaver confirmed that she had messaged the Secretary of State for Housing, Communities and Local Government who confirmed that Council's can propose at any time a request to becoming a unitary authority. With regards to the size of the unitary authority, Victoria Weaver suggested that different sizes could be looked at during the review.

#### 7. Public Engagement and Initiatives

Councillor Scordis introduced the Public Engagement and Initiatives Report. The report requests that the Panel consider the methods for public engagement as outlined and that the Panel consider the format for the meeting on 19 September.

The Panel discussed the methods for public engagement, including the use of an online survey and the ability for members of the public to have their say at the meeting. In addition to this the Panel discussed the need to link the suggestions made into the strategic plan or those items that have already been added to the Policy and Public Initiatives Work Programme, which includes pedestrianisation of the High Street and Air Quality. It was also suggested that the form could include a question about whether members of the public would be attending the meeting.

In terms of those who attend the meeting, Panel members welcomed the suggestion of members of the public speaking at the meeting and the inclusion of flip charts to ensure that those who wished to attend the meeting, but not to speak would also be able to contribute.

With regard to the survey, Panel members were keen to see that the survey was publicised in the local press as well as through other means such as Councillors engagement through social media.

The Panel also discussed the possibility that ideas raised by members of the public may not be within the remit of Colchester Borough Council, and that there would also be a limitation on those ideas that would be feasible to review. It was acknowledged that expectations would need to be managed as part of this process and that the Panel would need to be prepared depending on the number of people who were going to attend. A member of the Panel expressed concern regarding the timescales and suggested a more long term approach be taken.

Adrian Pritchard, Chief Executive, highlighted the need to ensure that those issues that progress are ones that can be reviewed by the Panel and that there is a focus to the key areas.

The Panel also discussed holding an all Panel briefing in advance of the meeting to discuss the responses that had been received.

RESOLVED:

- a) The Panel considered the methods for public engagement in advance of the meeting and agreed that an online survey be created to capture suggestions in advance of the meeting.
- b) That members of the public be invited to the Panel meeting in September to suggest their ideas.

#### 8. Whole Council Elections

Andrew Weavers, Monitoring Officer, introduced the Whole Council Elections report. The report requests that the information provided in the report is noted and to consider whether the Panel should advise Cabinet to recommend to Full Council to authorise the commencement of the process to move to whole Council elections and if so whether these should be held in 2019 or 2020.

Andrew Weavers provided the Panel with a summary of the report and highlighted the current situation. Mr Weavers also noted that the frequency of Council elections had been considered twice in the last eight years, this included when there was an electoral review of the Borough. Andrew Weavers also highlighted the process for undertaking a change in electoral cycles, highlighting that it would require a special Council meeting to be convened and that it would impact on Town and Parish Councils as they would need to match the election cycle of the Borough.

Andrew Weavers also informed the Panel that if they were to move to whole council elections, it would not be possible to switch back to elections by thirds for a period of five years. Andrew Weavers highlighted that the report includes information on the advantages and disadvantages of each option and the costs associated.

Panel members thanked the Monitoring Officer for producing the detailed report. The Panel discussed the advantages and disadvantages of whole council elections and elections by thirds. Some members highlighted that elections by thirds can disrupt the work flow of the Council as due to the election period certain business has to be paused. Holding elections every four years could also present better opportunities for training Councillors as all Councillors will be up for election as well as provide for a more convivial environment. Members also acknowledged the possible savings of electing all Councillors every four years rather than in thirds.

A member of the Panel highlighted that elections by thirds tends to mean that the results relate more to the local political scene and that political parties at the Council were held to account more often due to the frequency of elections. Comments were also made stating that there was more political engagement when electing by thirds. Members of the Panel debated whether social media had provided another means of accountability for Councillors if the authority were to change to all out four yearly elections.

A member of the Panel highlighted that they felt that if there was a change to the elections process that holding elections in 2019/20 would be too soon and that it should be scheduled or 2022. Andrew Weavers stated that it is too soon to hold discussions around changing the electoral system in 2022.

Panel members considered the information and subsequent discussions. Some members were in favour of moving to whole Council elections and others expressed a preference for remaining electing by thirds.

#### RESOLVED

- a) That the Panel note the information provided in the report, with regard to the comparison between whole council elections and elections by thirds.
- b) That the Panel by FOUR votes to THREE advise Cabinet NOT to recommend to Full Council to authorise the commencement of the process to move to whole council elections.

#### 9. Work Programme 2018/19

Jonathan Baker, Democratic Services Officer, introduced the Policy and Public Initiatives Panel Work Programme 2018/19. The Panel is requested to note the contents of the Panel's work programme for 2018/19 as set out in the report.

Following on from the Public Ideas item at the beginning of the meeting Panel members agreed that a report be brought to a future meeting regarding the advantages and disadvantages of Unitary authorities.

Jonathan Baker also highlighted that the Panel would need to consider when it wants to receive information about the previous agreed items of air quality and pedestrianisation of the high street. A member of the Panel suggested that these items could be looked at following the public engagement session in September, as there may be ideas from this that influence discussions.









This places a barrier on a lot of people cycling and walking (if the facilities are poor near where they live or for the journeys they need to make). This in turn pushes people to use their cars more, even for short journeys within Colchester. This is vicious circle: the more people use their cars, and the more facilities etc rely on people using cars, the less attractive it is to cycle or walk. The health of the residents of the borough suffers, both because they are getting less exercise, and because air pollution is high. As a result, the borough is less economically productive than it could be as people are less productive and off sick more. An investment of, say, £5 million in decent infrastructure should very quickly pay off in terms of an improved local economy as Colchester becomes a more attractive and productive place to work and live.





Dear Mr Baker,

Reference e-mails below, I would be most grateful if you could please include the following comment from me for consideration by the Policy and Public Initiatives Committee meeting – which I gather is a public meeting – to be held tomorrow evening, Wednesday 19<sup>th</sup> September. Unfortunately I cannot attend because of a prior engagement.

The first thing Colchester Borough Council should do is scrap the Cabinet system of running the Council. It is not democratic. It denies all 51 democratically elected Borough Councillors having the same democratic rights in making decisions.

Putting most powers in the hands of just 8 Councillors is not democratic. It is wrong that 43 Councillors are denied being involved in the decision- making process. It is anti-democratic, in particular, to exclude the 25 Councillors who are members of the largest political group on the Council – and also wrong that the 18 "back bench" Councillors of the parties represented on the Cabinet (the so-called "Progressive Alliance", sic) are also excluded from the decisions made by the Cabinet.

All 51 Borough Councillors have an equal mandate of legitimacy, with each Councillor having been elected by residents in his or her Ward. All 51 Councillors should thus have an equal say – from the newest Councillor just elected to the Councillor who has served for many years.

Parliament has given local authorities the right to revert to a committee system, in preference to a cabinet system, so that all councillors can be involved in the decision-making process.

Colchester Borough Council could involve all Councillors by creating several Committees with a total membership of 100 places — each Councillor thus serving on two Committees, with the Mayor not being required to serve on two Committees during his or her year of office.

I applaud the Council in holding a public meeting to encourage residents to put forward their ideas to improve the Borough – but what the Borough Council also needs to do is to restore democratic involvement of all 51 Councillors.

I therefore suggest that the Cabinet system is abolished, and that a Committee system is introduced. When the Council puts its own house in order then it will be better placed to engage and involve the public who increasingly find themselves ignored by the Council. Hi Lesley,

Thank you for the link but I'm still having trouble with finding where to attach my ideas so would it be possible for you to share my opinions via this email. The Responsible Dog Ownership Strategy.

As you know I have personally been trying to help promote this strategy since 2012, but almost every dog owner I help within the area have no idea this strategy exists, let alone the content. Although the strategy itself seems to be outdated I know that there has already been much in the way of promoting the strategy with community days of action, particular dog related events, including Bark in the Park, but there has been such a rise in properties being built within the area over the last few year that the owners of dog that I meet have no idea these ever existed. There are many owners who love the idea of being able to include their family dog in days out, which is why there were more than a thousand people who attended the last Bark in the Park. Specific events like this would be an ideal opportunity to promote the Responsible Dog Ownership Strategy.

Even if there were funds allocated to the Animal Control team, or Zone Wardens, and even Ward Councillors, that maybe used to set up smaller dog shows within various areas of the Borough to help teach those interested the basics of their dogs language, behaviour, and lead training (common mishandling of the lead is the main cause of reactive dogs on lead). This was offered at Bark in the Park and was a great success, but something as big as Bark in the Park is likely bring in a wider family audience.

As for the strategy itself (or the Be a responsible dog owner page on the council website) I believe that there is room for improvement. The section related to training is wonderful because training a dog something new for 20 minutes, helps to tire a dog more than an taking them for an hours walk, ideal for rainy days. Exercise is important but brain stimulation is the main reason for taking a dog for a walk, after toileting of course, maybe that could be added.

The page itself is easy to read but adding everything the owner of a dog should be aware of in one place, highlighting the changes to specific acts; Livestock Act (possibility of dogs being shot), Anti-social Behaviour Act - Dangerous Dogs Act and so on, would help everyone to understand the law, and dispel many of the confusions related to the changes in the act. Especially highlighting that the specific changes effect all dogs, within all environments, because many still seem to believe that the changes are only relevant in public environments, and only relevant to the specific breeds named in the Dangerous Dogs Act.

One part I believe that should be removed (or changed) on the page, although I understand why it is on the page, is the suggestion that your dog should be neutered.

You have highlighted the some of the positive aspects related to having a dog being neutered, but there is also scientific evidence to suggest that neutering can lead to


#### health concerns.

There is also conclusive evidence to suggest that neutering a dog with anxiety or fear can exasperate the symptoms of the behaviour and create further behavioural concerns. Causing many to become reactive dogs.

I'm sure there is much more that I can offer, including offering my services to help with any up and coming events in the future, as I have in the past. But I would be very happy to offer any help with the Responsible Dog Ownership Strategy if this is reviewed, or maybe even Bark in the Park again. Maybe we can discuss a setting up a specific training programme, or dog walk once a month, run by the council to aid residents with any concerns they have about their dogs behaviour, language, psychology and training. Although it's important to add that I already do this individually during the free assessment, to help promote responsible dog ownership with Colchester Council, and some dogs need the security of the home to be able to learn. Many dogs and owners would greatly appreciate and thrive in a social environment as I'm sure you will remember from the years of the walks.
