The use of phones, tablets, laptops and other such devices is not permitted at Licensing Sub-Committee Hearings.

Mobile phones, pagers, cameras, audio recorders

Licensing Sub-Committee Hearing Procedure for Hearings under the Licensing Act 2003

- (1) All questions and statements will be directed through the Chairman.
- (2) The Chairman will at the beginning of the Hearing explain to the parties the procedure to be followed and shall consider any request made by a party for permission for another person to appear at the Hearing.
- (3) The Hearing shall take the form of a discussion led by the Council's representative.
- (4) Cross examination shall not be permitted unless the Sub-Committee considers that cross-examination is required for it to consider the representations, application or notice as the case may be.
- (5) The Chairman of the Sub-Committee may require any person attending the Hearing who in his opinion is behaving in a disruptive manner to leave the Hearing and may:
 - (a) refuse to permit that person to return, or
 - (b) permit him to return only on such conditions as the Sub-Committee may specify.

Provided that any such person may before the end of Hearing submit to the Council in writing any information which they would have been entitled to give orally had they not been required to leave.

- (6) A party who wishes to withdraw any representations they have made may do so:
 - (a) by giving notice to the Council no later than 24 hours before the day or first day on which the Hearing is to be held, or
 - (b) orally at the Hearing.
- (7) The Sub-Committee in considering any representations or notice made by a party may take into account documentary or other information produced by a party in support of their application, representations or notice (as applicable) either before the Hearing, or with the consent of all other parties, at the Hearing.
- (8) The Sub-Committee shall disregard any information given by a party or any person to whom permission to appear at the Hearing had been given which is not relevant to:
 - (a) their application, representations or notice(as applicable) or in the case of another person, the application representations or notice of the party representing their appearance, and
 - (b) the promotion of the licensing objectives or, in relation to a Hearing to consider a notice given by a chief officer of police, the crime prevention objective.
- (9) If a party has informed the Council that he does not intend to attend or be represented at a Hearing, the Sub-Committee may decide to proceed with the Hearing in his absence.
- (10) If a party has not informed the Council that he does not intend or be represented at a Hearing and fails to attend or be represented at a Hearing, the Sub-Committee may:
 - (a) where it considers it to be necessary in the public interest adjourn the Hearing to a specified date (notice being given forthwith to the parties concerned of the date, time and place to which the Hearing has been adjourned), or

(b) hold the Hearing in the party's absence

Where the Sub-Committee agrees to hold the Hearing in the absence of a party, the Sub-Committee shall consider at the Hearing the application, representations or notice made by that party.

The Council's case:-

(11) The Chairman will invite the Council's representative to summarise the report relating to the application under consideration.

The Applicant's case:-

- (12) The Applicant and/or representative will begin with their opening remarks and present their case.
- (13) The Applicant's witnesses (if any) will give evidence in support of the Applicant's case.
- (14) The Applicant and/or representative may question the Applicant's witness again to clarify any points which may have arisen.

Submissions from other persons or their representatives and from Responsible Authorities:-

- (15) Each party will present their case.
- (16) Each party's witnesses (if any) will give evidence in support of the party's case.
- (17) Each party and their witnesses may be questioned by the Chairman and members of the Sub-Committee.
- (18) Each party may question their witness again to clarify any points which may have arisen.
- (19) If the Applicant or other parties wish to question each other, questions may be directed through the Chairman.
- (20) Closing Statements may be made by the Applicant and/or representative.
- (21) The Chairman will ask the Legal Advisor whether there is anything else to be raised or settled before the proceedings are closed.

<u>Determination of the application by the Sub- Committee</u>

- (22) The Applicant and/or representative, other persons, Responsible Authorities and the members of the public and the press will leave the room to allow the Sub-Committee to determine the application. During this process the Sub-Committee members may ask for legal advice from the Legal Advisor.
- (23) The Applicant and/or representative, other persons, Responsible Authorities and the members of the public and the press will be invited to return to the room when the Sub-Committee's determination will be announced. Written details of the determination and the grounds upon which it is based will be sent to all parties concerned in accordance with the Hearings Regulations.

- If a Councillor has a disclosable pecuniary interest in a matter being considered at a meeting, he/she must not participate in any discussion or vote on the matter at the meeting. The Councillor must withdraw from the room where the meeting is being held unless he/she has received a dispensation from the Monitoring Officer.
- Where a Councillor has another pecuniary interest in a matter being considered at a meeting and where the interest is one which a member of the public with knowledge of the relevant facts would reasonably regard as so significant that it is likely to prejudice the Councillor's judgement of the public interest, the Councillor must disclose the existence and nature of the interest and withdraw from the room where the meeting is being held unless he/she has received a dispensation from the Monitoring Officer.
- Failure to comply with the arrangements regarding disclosable pecuniary interests without reasonable excuse is a criminal offence, with a penalty of up to £5,000 and disqualification from office for up to 5 years.

2. Conditions

Offered on the operating schedule

- 1. A CCTV system will be installed, or the existing system maintained, such system to be fit for the purpose.
- 2. The CCTV system shall be capable of producing immediate copies of recordings on site. Copies of recordings will either be recorded on good quality video tape or digitally on to CD/DVD or other equivalent medium.
- 3. Any recording shall be retained and stored in a suitable and secure manner for a minimum of 28 days and shall be made available, subject to compliance with Data Protection legislation, to the Police for inspection on request.
- 4. The CCTV system will incorporate a camera covering the entrance door and the alcohol display areas and will be capable of providing an image which is regarded as identification standard. The precise positions of the cameras may be agreed, subject to compliance with the Data Protection legislation, with the Police from time to time.
- 5. The system will display, on any recording, the correct time and date of the recording.
- 6. The system will be in place to maintain the quality of the recorded image and a complete audit trail maintained.
- 7. The CCTV system will be maintained so as to be fully operational throughout the hours that the premises are open for any licensable activity.
- 8. The premises licence holder will at all times maintain adequate levels of staff. Such staff levels will be disclosed, on request, to the licensing authority and police.
- 9. Adequate waste receptacles for use by customers shall be provided in and immediately outside the premises.
- 10. The premises licence holder will ensure that an age verification policy will apply to the premises whereby all cashiers will be trained to ask any customer attempting to purchase alcohol, who appears to be under the age of 25 years (or older if the licence holder so elects) to produce, before being sold alcohol, identification being a passport or photocard driving licence bearing a holographic mark or other form of identification that complies with any mandatory condition that may apply to this licence.

3. Policy Context

Policy references are given for guidance only, they should not be regarded as a substitute for the Policy which contains the necessary detail for all parties in making and determining applications

- 2.2 The aims of this Licensing Policy are to pursue and promote the licensing objectives by encouraging:
 - Desirable destinations for a wide range of age groups
 - Licensed premises suitable for the area within which they are located
 - Diversity of entertainment throughout the town centre that appeals to a wider audience
 - A wide range of uses of premises
- 2.6 The Licensing Authority considers it extremely important that licensed premises operate as good neighbours within their community. Operators of licensed premises are encouraged to consult with local residents and businesses prior to submitting applications to ensure they are aware of, and can address, any needs or concerns they may have.
- 2.7 Additionally, existing licensed premises are encouraged to have regular dialogue with residents and businesses in the local area to ensure the promotion of the licensing objectives on an ongoing basis.
- 2.11 If there is a relevant representation, the application will be considered against the policies and steps taken which are appropriate and proportionate to promote the licensing objectives
- 2.15 It is acknowledged that conditions can only be imposed that seek to manage the behaviour of customers when they are on the premises and within the control of the licensee or in the immediate vicinity of the premises.

4. Background Information

Information relevant to the licensing and/or operation of the premises

The application in front of the Sub-Committee has been reduced in scale by the applicants and is now in line with the planning consent for the site which permits operating hours of 07.00 to 23.00. Please note the hours and activities now requested are those set out in this report and not those contained in the application at Appendix 1

Representations to the original application were received from local residents, Environmental Control and the Licensing Authority. Following the reduction in hours for the sale of alcohol and the removal of late night refreshment from the application, the Licensing Authority, Environmental Protection and some local residents have withdrawn their representations. The representations contained in the report are from residents who have either expressly indicated that they wish to maintain their objection or from residents who have not indicated whether they wish to withdraw their representation in the light of the amended application.

5. Options available to the Sub-Committee

The Sub-Committee must take such of the following steps as it considers appropriate to ensure the promotion of the licensing objectives –

- Grant the application as requested
- Grant the application whilst imposing additional conditions
- Exclude or reduce the hours of operation of any licensable activities included within the application
- Reject the whole or part of the application





I would like the BP garage to be refused a 24 hour license to sell alcohol and refreshments.

My four points for refusal are as follows:

- 1. There will be more crime and disorder. As people will be hanging around drinking. I have already had a very long pole which went across the wall at the front of the house. Pulled out of the wall, an thrown at my car. The pole is at the side of the driveway now. (photo on request or pop along an see it) This was when the Esso garage was open 24 hours. I never put the pole back as young people were continually being a nuisance. They threw rubbish in the garden. Ripped up plants. Throw things at the car etc. Sit on the grass verge singing, whilst they were drunk. The police didn't want to know.
- 2. Public Safety. Well, its not safe when drunk idiots are throwing poles at cars. They also wheel spin out the garage late at night. There have been a few near misses. A car hit the bollards, when a young guy wheel spinned out of the garage in front of him. I don't feel safe taking the dog for a walk late at night. Esp when alot of men are around the garage. And they are driving like idiots. I worry in case they mount the pavement and hit either the dog and myself. Or who ever i maybe with.
- 3. Public Nuisance. Is when people rip my pole out an throw it at the car! Making a noise. Loud music. Laughing, mucking around, shouting, arguing, singing, wheel spinning, revving engines, skidding around the road to an from the garage. Pulling up plants, jumping on an of my wall. Kicking my wall. Now part has broke. (again photo on request or pop along and see it)
- 4. Protection of children under harm. I have my 4y grandaughter, every other weekend. Plus 2/3 days and nights in the week. She goes to bed between 7pm - 8pm. I also have my other 2 grandaughters who live in Carlisle down for 2 - 3 weeks summer holidays, and either a week or all over Christmas. I really don't think it would be safe or fair to have the garage open 24 hours with alot of young children either staying or living opposite the garage. With the behaviour of the so called adults, i dont think its safe. the noise frightens the children. When people are trying to damage my property, that really scares them.

Also the lights from the garage are very bright. They shine through the curtains. When the Esso was there, I used to have put a thick blanket up around the curtain pole to help keep the lights out. I really don't want that all night.

I gather that Eastwood Service Station is applying for a licence to serve alcohol and to stay open all night.

To both these, I wish to register an objection.

I believe it is inappropriate to mix alcohol and driving, even at arm's length like this, so alcohol at service stations is not wise. Only this last week the Essex County Standard reported not a few cases of drivers convicted for being severely over the legal limit. We should minimise this risk.

It is also inappropriate to have such premises open through the night in a residential area. The disturbance of bright lighting and the noise of cars braking and then accelerating out of the station would disturb nearby houses in all directions.

There is also a risk that passers-by on foot, even those turned away from the nearby public house because of their inebriation, would avail themselves of the facilities and cause local noise, littering and vandalism, of which we have unfortunate experience in the past.

For both shopping and petrol purchase, there is already 24-hour provision at the Tesco Extra store which is very close.





24 Hour Opening and Alcohol Licence.

It is obvious to me that BP fails to grasp the concept of a residential area. A place where residents have a right to peace and quiet. Article 8 of the Human Rights Act acknowledges the right to the enjoyment of our homes. Eight hours night time respite is recognised by the World Health Organisation the Planning and Environmental Depts. C.B.C.

Perhaps BP has yet to acknowledge that this is not an Industrial site in Bingley. (see Planning Application 160608).

A RESIDENTIAL AREA IS NOT THE PLACE FOR A 24 HOUR SERVICE STATION. ESSO TRIED BETWEEN FEBRUARY 1992 AND March 1996. This came about because Redevelopment in 1983 left the site without any conditions, creating a living nightmare for residents. Mr Colin Daines the Environmental Officer C.B.C. tried to encourage the staff of Eastwood to control the noise. (even offering relocation) Control was beyond their capabilities. So in Summer 1995 a Noise Abatement Notice was issued, the noise continued unabated resulting in the court order. Closure was set for March 11th 1996. It was established that it is impossible to control customer noise, which is generated when entering the forecourt, whilst on the forecourt and when leaving. I do not believe BP would be able to control customer noise either. I certainly do not wish to repeat the 4 year saga of 24 hour opening, and I am certain neither does the council.

The noise generated by customers on the forecourt can be discerned well above the road noise. Traffic Flow is very different from Doors Banging, Shouting, Horns, Music, Alarms Tannoy system at full throttle, Screeching Tyres and Accelerations. The human ear is more receptive to these sounds. When the road traffic dies down during the evening these intrusive sounds suddenly become even more invasive.

Over the past three weeks since closure prior to re-development, the noise levels on the road have dropped dramatically, demonstrating that most noise nuisance rests squarely with the petrol station.

My request to the team is to refuse this Licence application for 24 hour opening. After 11pm the only real noise will be generated by customers going to and from the petrol station. After midnight/1am when the street lights are switched off, it will result in one huge mass of light, when the whole area should be in darkness, conducive to sleep. Our homes will be invaded by the light pollution from the site and from the headlights of the vehicles leaving the petrol station.

Alcohol Licence. I do not see the need for an all day Licence perhaps 6pm to 10pm would be more appropriate.

I respectfully request the team to reject the 24 Hour opening and retain the conditional opening hours agreed at committee on 30th June 2016 of closure from 11pm to 7am, thus maintaining the equilibrium between business (BP our neighbour) and the required respite of 8 hours for the residents.

MY REASON FOR OBJECTION:-

Eastwood, established long after the houses were built, was redeveloped in 1983.

Between February 1992 and March 1996 the garage opened without notification for 24 hours a day, 7 days a week all year. This was due to the lack of conditions being placed in 1983.

The nightly intrusion over a 4 year period was intolerable for residents (logged nightly at the request of the Environmental Dept.) If you are deprived of sleep, eventually you are unable to function during the day.

It was accepted that noise generated on a forecourt is impossible to control by a council or owner of a site. Eventually a Noise Abatement Notice was issued. Because of their inability to abide by the Noise Abatement Notice, Esso was taken to the Magistrates Court December 1995 resulting in closure overnight from March 1996. A sort of peace prevailed, but the Order was infringed on numerous occasions. A 24 hour Licence application made earlier this year was quickly withdrawn.

I believe the uncomplicated conditions imposed by C.B.C. on 30th June 2016 is in the best interest of B.P. the residents and the council. Closure between 11pm and 7am. No deliveries outside of these hours. No setting up or removing stands on the forecourt between 11pm and 7am. Easy for staff to follow and easy for the council to enforce.

With a shop 3 times larger it would be assumed that noise nuisance would increase above the levels of 92/96.

Then on a nightly basis it became a, Meeting place for youths, Taxi cabs with radios playing, boot and bonnet banging and talking.(shouting) Late Night Revellers after leaving the town centre. Football matches using tin cans, several fights. Customers' radios, shouting, door slamming, horns and alarms etc.

By midevening the road quietens, and with the street lights being extinguished Midnight/1am it is pitch black. This redeveloped, highly illuminated site will shine like a beacon into our homes and be a magnet for all the aforementioned to the detriment of this wholly residential area, and the sanity of the residents.

The residents are entitled to the right of enjoyment of their homes so that is why I again ask you to reject the Licence for 24 hour opening.

I do not believe a garage is a suitable place for an Alcohol Licence, however I will not object to it being granted between 6pm and 10pm.

This is an addendum to our correspondence 4th & 5th September 2016.

The residents surrounding this site are entitled by right to receive the 8 hours respite agreed on 30th June 2016 by the Planning Committee, something we have been deprived off for over 2 decades.

Planning Consent was agreed for a 3 times larger shop with opening times 7am to 11pm conditional. We require this to remain.

I believe all parties concerned need to recognise this is a wholly residential area, totally unsuitable to 24 hour opening. Nightly disturbances endangers our health.

Considering the expanded redevelopment that has been consented to BP, this Licence Application demonstrates a perverse affront and slight to all the residents. After due consideration we feel that the area will not benefit from the issuing of an Alcohol Licence, once again it become a magnet for youths probably resulting in underage drinking. There is evidence around the area of drinking sessions, resulting in litter and noise nuisance.

Our previous correspondence stated we would not object to the Alcohol Licence between 6pm and 10pm. We withdraw this and require the team to reject both 24 hour opening and the 6am to midnight Alcohol Licence.

Twenty four hour opening made residents' lives hell. Rejecting this application in its entirety will return the equilibrium between residents' and business needs.

Those who get too little sleep are also known to eat more and have unhealthier diets than those who get a good

night's rest. And those who sleep for too long are likely to be less active during the day.

The experts stressed that there is no firm evidence for what constitutes too much or too little sleep - but around eight hours is considered the ideal for most adults.

Dr Marie-Pierre St-Onge, of Columbia University In New York, said: 'Patients need to be aware that adequate sleep is important, just as being physically active and eating a balanced diet are important for cardiovascular health.'

I am writing to object to the above application, which will impact significantly on the quality of the local environment with light and noise pollution, from vehicles and people and site amenities.

It is not necessary to offer this facility to this area as petrol and food are available on a 24 hours basis at a supermarket outlet on the local Highwoods estate.

fear this proposal, if allowed, will impact substantially on my family's ability to have quiet enjoyment of our home or allow sufficient darkness to enable us to sleep in the overnight/early hours which will directly affect our quality of life in a negative way -denying us the right to get restful sleep in night-time hours.

As well as noise and light pollution, and I believe that perception of noise is magnified to the human ear in the traditionally quiet night time hours, I am also concerned at the effect of social disturbances by the site becoming a magnet for practices such as late night car racing, a meeting-up point, and general noise disturbance e.g. anti- social behaviour.

None of this will be conducive to sleeping, nor will the light pollution and lack of darkness to aid night time rest, which could impact on the health of my family both day and night due to the stress and lack of sleep if this application is granted.

I believe BP proposals to impose 24 hour business operations on residents are detrimental and inconsiderate to their neighbours.

I do not support the sale of alcohol at a garage site in order to dissuade drink driving, but at any rate believe it should be strictly limited for instance from 6pm to 10pm only.

But my overall request is that the conditional closure during the hours 11pm to 7am at this site -thankfully imposed by the reasonable analysis of the planning committee of Colchester Borough Council on 30th June 2016- be both upheld and guarded in perpetuity.

I believe this stance is in accordance with the right to peace and quiet as set out in Article 8 of the Human Rights Act, and also the eight hours night time respite recognised by the World Health Organisation and formally request that this simple clause be upheld as part of a condition of any type of operation at this site, both now and in the future.

The illumination of the site, which BP are providing entirely unreasonable assertions over in terms of measurement of effect to the environment, would also be of grave overnight concern to me, in fact the harshness of LED lights is unsatisfactory and difficult to look at in a residential area. Headlights from cars are also intrusive through bedroom curtains.

For the sake of providing a decent environment to enable local residents to have any chance of rest and peace at night, please reject this application.

I am writing to lodge my formal objection to the above application, which would cause a materially different environment in this locality due to a combination of noise, social and light disturbance, changing forever this historically residential area to a commercial all-night zone.

As a local resident I fundamentally disagree with this latest proposal. It will rob my family and I of any chance of a peaceful and quiet enjoyment of our homes, leaving us with no ability to get restful sleep in night-time hours.

This is due to the considerable noise which results from the operation of the garage and the customers who use it, and the beaming LED lights which BP keep insisting has no environmental impact, despite not living opposite them themselves, an opinion from which I beg to differ.

BP's attitude towards residents I believe does not look well on them and we have enjoyed a much quieter environment during the temporary garage closure, thus proving the impact of this business.

The sale of alcohol will further encourage an all night noisy environment with banging doors, people arguing in the early hours, increased all night road traffic and operational sounds / car alarms / head lights and the likelihood from historic experience from 1982-1986 when 24 hour opening occurred is that, realistically, the garage will become a magnet for socially undesirable activities which will make everyone feel considerably less safe in our own homes.

We need the chance for peace and quiet so we can function normally during the day.

I therefore request that the conditional opening that the planning committee of Colchester Borough Council imposed on 30th June 2016 at this site, stipulating closure from 11pm to 7am in accordance with the right to peace and quiet as laid out in Article 8 of the Human Rights Act, and eight hours night time respite recognised by the World Health Organisation be upheld.

This straightforward clause is critical to the protection of the environment for local residents against both the noise levels and the light pollution which would otherwise pour into our homes illuminating our night time hours like a green beacon.

I also request that if an alcohol licence be granted at all that it be granted only restricted to the hours between 6pm and 10pm.

Please reject this application and afford the residents and local area the protection we surely need,

There are several outlets on Ipswich Road that already sell alcohol until late or all night besides Highwoods Tescos being open 24 hours which is just minutes away from the garage.




I write to inform you of my absolute opposition to the (carefully worded) application to open the petrol station on the Ipswich road 24 hours a day.
