1. **Executive Summary**

Decision to allocate £230,000 Voluntary Welfare grant 2018/19 to groups or organisations through an application process. All projects must meet at least one of the following criteria:

- Increasing volunteering across the borough. •
- Helping people improve their skills for work or life. •
- Preventing isolation and/or loneliness. •
- Enabling people or groups to do more for themselves in their communities. •
- Helping the most vulnerable people in our society to improve their quality of life and • opportunities.
- 1.1 Over £500,000 worth of application requests were received. A total of £190,000 is to be allocated from April 2018 to the groups and organisations listed below. A further £40,000 to be allocated to Community360 to provide support to local groups to aid them in achieving their goals. In addition Community 360 will provide a monitoring service for Colchester Borough Council in relation to the funded groups to ensure targets and outcomes are being achieved.

2. **Recommended Decision**

2.1 To award funding to the following groups or organisations:

- 2.2 To award Community360 a grant of £40,000 on condition of signing a Service Level Agreement. This is to provide support to the voluntary sector in Colchester and monitor grants. This is outlined in Appendix B
- The available funding does not allow allocation to all the organisations and groups who 2.2 applied. Over £500,000 worth of requests were received. The following applications were not successful, either because the criteria was not fully met or was not as strongly met as those that are selected to receive funding.

3. Reason for Recommended Decision

3.1 To approve the grant funding allocations as agreed by the panel.

4. Alternative Options

4.1 To not award funding to the groups or organisations listed above.

5. Background Information

- 5.1 The Voluntary Welfare grant has been allocated to Colchester groups or organisations for more than 15 years. Throughout that time the recipients did not have to apply for the grant and the payment was dependent on the negotiation and signing of a service level agreement or a condition of grant. All of the recipients delivered a service that met strategic plan outcomes.
- 5.2 In 2016 the Portfolio Holder for Communities made a decision that in order to make the Voluntary Welfare Grant open and transparent, it should be advertised for organisations to bid for.
- 5.3 To reduce the impact to groups who had received this grant for many years' meetings were held with each of the funding recipients to explain the change in allocating the grant. This provided 18 months' notice of the change to the groups to prepare for the potential loss of funding.
- 5.4 The application process opened online on the 24 July and closed on 29 September 2017. The minimum that groups could apply for was £5,000 and the maximum £50,000
- 5.5 All applications were considered and evaluated against the criteria along with the overall benefits that could be delivered and the portfolio holder for Housing and Communities decided on the final allocation set out in this report.
- 5.5 The funding is for a one year period and is paid in two instalments on condition of the signing of a negotiated agreement and demonstration through monitoring that targets and outcomes are being achieved.

- 8.1 The Voluntary Welfare grant 2018-19 support the Colchester Borough Council Strategic Plan 2015-18 by meeting the following;
 - <u>Vibrant</u> Develop a strong sense of community across the Borough by enabling people and groups to take more ownership and responsibility for their quality of life. Create the right environment for people to develop and flourish in all aspects of life both business and pleasure.
 - <u>Thriving</u> Be clear about the major opportunities to work in partnership with public, private and voluntary sectors to achieve more for Colchester than we could on our own.

• <u>Welcoming</u> – Ensure Colchester is a welcoming and safe place for residents, visitors and businesses with a friendly feel that embraces tolerance and diversity.

9. Consultation

9.1 During 2016 the Portfolio Holder and Council Officers met with all of the existing voluntary welfare grant recipients. The meetings provided an opportunity to explain the change in the way that the grant is being administered from 2018-19 and to allow groups to make alternative plans if they are not awarded a grant or a reduced grant.

10. Publicity Considerations

- 10.1 One group that has previously received a voluntary welfare grant and has not been allocated funding this year is the Rural Community Council of Essex. RCCE may try to reverse the decision made by the funding panel. The Council continues to support RCCE through a financial contribution to the Rural Housing Enabler.
- 10.2 The decision regarding which organisations to fund was made by the voluntary welfare grant funding panel in October. However, there are projects that were not successful in securing the funding and will be disappointed at the outcome.

11. Financial implications

- 11.1 Cabinet agreed the Voluntary Welfare grant funding of £230k in the fees and charges 2018/19 report.
- 11.2 The majority of grants will be paid in two instalments dependant on the return of satisfactory monitoring to Community360. The first payment in April 2018 and the second scheduled for October 2018.
