Audio Recording, Mobile phones and other devices

The Council audio records public meetings for live broadcast over the internet and the recordings are available to listen to afterwards on the Council's website. Audio recording, photography and filming of meetings by members of the public is also welcomed. Phones, tablets, laptops, cameras and other devices can be used at all meetings of the Council so long as this doesn't cause a disturbance. It is not permitted to use voice or camera flash functions and devices must be set to silent. Councillors can use devices to receive messages, to access meeting papers and information via the internet. Looking at or posting on social media by Committee members is at the discretion of the Chairman / Mayor who may choose to require all devices to be switched off at any time.

The role and work of the Crime and Disorder Committee

The role

The Committee shall meet to review or scrutinise decisions or other actions taken in connection with the functions conferred to the Committee, these being, a strategy for the reduction of crime and disorder in the Borough and a strategy for combating the misuse of drugs in the borough.

The Committee has to meet at least once in every twelve month period.

The Committee may co-opt persons to serve on the Committee who are members of the public, employees, officers or members of responsible authorities, for example, the Council, Essex County Council, Essex Police Authority, Essex Fire and Rescue Authority and the Essex Probation Service.

Executive members of the Council may not be co-opted to the Committee. Co-opted persons shall not be entitled to vote on any matter, unless the Committee so determines.

The work

The review of the Safer Colchester Partnership will be a year on year substantive report to be considered by the Committee.

Any Member of Colchester Borough Council may give written notice to the Scrutiny Officer that they wish an item to be included on the agenda of the Committee in relation to a local crime and disorder matter. If the matter is considered a local crime and disorder matter, the item will be included on the first available agenda of the Committee.

A crime and disorder matter is a matter involving anti-social behaviour or other behaviour adversely affecting the local environment, or the misuse of drugs, alcohol and other substances.

The Committee once it has considered a local crime and disorder matter shall consider whether or not to make a report to the Cabinet or Council, and if it decides not to, shall notify the Councillor concerned of its decision(s) and the reason(s) for it.

If the Committee decides to report to the Cabinet or Council, it will provide a copy of the report to the Councillor concerned and the responsible authorities and co-operating persons or bodies as appropriate.

19. Election of Chair for the Meeting

In the absence of the Chair and Deputy Chair, clarification was sought as to whether a substitute member could be elected to chair the meeting. Richard Clifford, Lead Democratic Services officer, advised that it was for the Committee to elect a chair from amongst those members attending the meeting, including any substitute members.

RESOLVED that Councillor Darius Laws be elected as chair for the meeting.

21. Safer Colchester Partnership

This interim report provided the Crime and Disorder Committee with the opportunity to review the work of the Safer Colchester Partnership during the period September 2018 – January 2019. The report was presented by Pamela Donnelly, Chair, Safer Colchester Partnership.

Have Your Say!

Parish Councillor Robin Rennie

Parish Councillor Robin Rennie attended to speak in his capacity as a member on Great Horkesley Parish Council. He raised concern regarding the apparent rise in antisocial behaviour and crime, especially within Colchester town centre. He informed the Committee that he had proposed to Great Horkesley Parish Council that it considers funding a position for a Special Constable to work within the Parish. Conversations have been held with Myland and Boxted Parish Councils regarding cooperation to provide this across the area that they covered.

Pamela Donnelly, Chair of the Safer Colchester Partnership

Pamela Donnelly confirmed that she was aware of the work being done by Great Horkesley Parish Council in this area. Safer Colchester Partnership's aim is to move into providing support for rural communities in tackling issues. An initiative will be launched to assist parish councils in identifying what support is available for them. Furthermore, the Cabinet is planning to invest in additional resources for rural policing. Pamela explained that she would discuss this with the Borough Commander upon his return to duty. She recommended that the content of the next Safer Colchester Partnership report to the Committee be widened in order to provide a briefing on this rural work. Pamela Donnelly restated the intention that there would be consideration and action taken in the future to address rural issues, to compliment and build upon Essex Police's Rural Crime Strategy 2017.

Louise Wishart

Louise Wishart attended the meeting to have her say on behalf of the Williams Walk and Dutch Quarter Neighbourhood Watch. Residents have been reassured by the increase in patrols by Police Community Support Officers (PCSOs), Police Officers and Military Police. She raised the discussions held by the Committee on 11 September regarding potential uses of technology to reduce crime, noting that Councillor Lilley had committed to ascertaining the likely cost of increasing CCTV coverage in the Dutch Quarter. She requested information on any quotations received, the likely timetable for the tendering process and related decision making and whether the Council had plans to provide increased camera coverage.

Pamela Donnelly, Chair of the Safer Colchester Partnership

Responding, Pamela Donnelly informed those present that Cllr Lilley was unable to attend this meeting and had given his apologies. She explained that the Council was reviewing its CCTV coverage. Capacity being limited, it was currently not possible to add any further functionality to the existing network. Members of the Safer Colchester Partnership have been working with colleagues from Colchester Amphora Trading Ltd to explore the cost of a new, state-of-the-art CCTV system. The review is underway, and a commercial tendering process will be the next step. Further information would be provided. once the current review into coverage was completed, as the current system had no capacity for increased coverage or functionality.

A member of the Committee requested clarification as to whether extra CCTV were to be installed as part of the 'Fixing the Link' Project and, if so, whether there was capacity for them on the current system. In response, Pamela Donnelly explained that the system was currently at maximum capacity, but that additional CCTV camera sites could be provisionally agreed, pending the introduction of a new system with increased capacity to manage them. She offered to provide Committee members with additional information on this, should they wish to see greater detail.

Safer Colchester Partnership Presentation

The attending representatives of organisations within the Partnership were introduced and thanked:

- Superintendent Tom Simons, Essex Police (attending in place of Chief Inspector Shaun Kane)
- Michelle Behn, Essex Ambulance Service
- Melanie Rundle, Safety and Protection Manager, Colchester Borough Council
- Sonia Carr, Community Safety Co-ordinator, Colchester Borough Council

Pamela Donnelly introduced the presentation which focused on the Partnership's work in the town centre and the Town Centre Action Plan. Future work will address rural issues, which will be reported back at a future meeting.

Superintendent Tom Simons, Essex Police

The Superintendent provided an update on work being done to investigate the murder of Carl Hopkins. A suspect has been arrested, charged and remanded. The Police believed that this crime was related to the supplying of drugs. Leads have been generated and have allowed for measures to be taken within Operation Smuggler, dealing with County Lines activities.

Regarding crime and antisocial behaviour, the Superintendent explained that he was focussed on addressing the root causes, rather than just addressing the consequences. This will involve looking at organised crime groups (including some in Colchester), County Lines activities and other areas. Violent crime has risen in Colchester, partly because of improved reporting, but also in general. The focus of the Chief Constable is to address issues relating to 'victims, visibility, vulnerability and violence'.

Team 10 is now in place in Colchester, whilst Essex-wide, 150 new officers have joined over the last 6-12 months. Funding for a further 52 officers across the Force has now been secured, with the emphasis of their work being the policing of town centres. Assurance was given that continuity is being maintained during the temporary absence of Chief Inspector Shaun Kane. A briefing for Borough Councillors by the Police, Crime and Fire Commissioner is due to take place on 4 March. This will give further detail on police investment in the Borough.

Sonia Carr, Community Safety Co-ordinator, Colchester Borough Council

Sonia Carr provided a recap of the problems regarding aggressive begging, street sleeping and antisocial behaviour which had led to the introduction of the Public Spaces Protection Order in Colchester town centre, implemented in October 2017. Details were given of the Order, and the additional enforcement options which it permits for the Council and the Police. The Order will last until 2020. Good results have been achieved, but a wider mix of powers are now being looked at in order to further address begging, antisocial behaviour, drugs, street drinking and to assist information sharing between agencies.

The Town Centre Action Plan and its partnership arrangements were described. Work had been delivered, but co-ordination had been problematic. Closer working and greater communication between organisations have now been introduced and is proving successful. Hotspots of antisocial behaviour are being tackled. Developments have included:

- Longer patrols by Zone Teams, up to 9pm
- Police launching Operation Diss to support the Town Centre Action Plan
- A review of enforcement action taken

- Between August 2018 to December 2018, the fourteen persons identified as causing significant harm and distress in the town centre had been reduced to ten, through positive partnership work
- Standard operating procedures on enforcement have been laid down to give all agencies clarity and consistency.
- A strategic group has been formed to oversee the Town Centre Action Plan, communicating successes and addressing problem areas
- Short-term periods of keeping street lighting on overnight, where hotspots of criminal activity have been identified (e.g. Eld Lane)
- Street cleanliness has been addressed, with new recycling bins and the Gumdrop campaign
- Representative of the National Probation Service now participates in weekly meetings of partners in the Town Centre Action Plan

Sonia Carr briefed the Panel on Team 10, its aims and actions to address antisocial behaviour, begging and street drinking. Investment for this has been provided by the Police, the Borough Council and other partner organisations. The overall investment has been almost £600k. Details of patrols, partners in the local business community and enforcement action statistics were given to the Panel.

Examples of the communications/press activity covering progress and successes were shown to the Panel.

Sgt. Martin Willsher, Essex Police (Team 10)

Sgt. Martin Willsher provided the Panel with a case study involving enforcement action taken to address antisocial behaviour by one of the individuals identified as being most disruptive. The individual was a well-known persistent aggressive beggar who is not homeless. Initial action was to issue a Community Protection Warning against him. This was breached, which led to the issuing of a Community Protection Notice against him. Several breaches of this have now led to successful convictions. A Criminal Behaviour Order was then successfully applied for and granted. This was breached numerous times within a week of it being issued, leading to a successful prosecution resulting in a custodial sentence.

Matt Chittock, Colchester Borough Council, Zone Warden from Zone Team 2

Matt Chittock explained that the information sharing carried out within the Town Centre Action Plan, enhanced by Team 10, has been effective and disruptive individuals have been identified and addressed. In some instances, this has been to find ways to provide housing and to resolve cases of street homelessness, in addition to the cases which resulted in the use of enforcement powers.

Committee Discussion

A Committee member asked for detail on how the Police would address situations where a young person was suspected of travelling to Colchester in order to transport drugs, and whether there was a mechanism by which social services can be liaised with to ascertain if there was already existing concern regarding the individual, or to flag up the concerns of the Police.

Superintendent Tom Simons related some of his experience in dealing with such situations, having previously taken a lead role on public protection, including how the Police service liaised with social care, developing how referral of concerns are made. Where it is suspected that a minor is involved in illicit activity (e.g. the drug trade), the primary concerns are the vulnerability and safeguarding of the individual, with criminal elements of cases dealt with at a later time. A referral form is completed by the Police raising concerns. This is sent to social care who provide it to the social care team in the area from which the individual has come.

A member of the Committee raised questions regarding the 'Your Kindness Kills' campaign, specifically relating to future Borough Council actions to raise awareness of contactless donation possibilities.

Mel Rundle explained that Cllr Mike Lilley (Portfolio Holder for Planning, Public Safety and Licensing) had asked for research to be done on contactless donation schemes which could be used to handle donations to those in genuine need. A scheme was being designed in partnership with Colchester Borough Homes for implementing the roll-out of an app. The Council is mindful of the need to consult with the public, service users and residents, whilst avoiding telling members of the public what (in the Council's view) they should do and on what their donations should be spent. A formal proposal will then be put to the Portfolio Holder and then the approved scheme will be advertised.

The Committee raised the issue of mental health and wellbeing of front-line staff, especially where they are engaged in carrying out policy such as the removal of rough-sleeping items from the street. Mel Rundle informed the Committee that a standard operating procedure was in place to cover this, with direction that items should only be removed if unattended for 30 minutes or longer. This is to allow genuine rough sleepers the chance to leave their items for short periods, for example to collect food, and ensure that only abandoned items are collected. Instances had previously been experienced where possessions had been left unattended for longer than thirty minutes when the individuals were away and undertaking illegal activities.

Questions were raised about the CCTV coverage, with one member questioning a town centre location which had no coverage on the Council's network. Concern was raised that this was close to a landmark site and assurance was sought that key tourist sites and main routes should and will be covered. The suggestion was made by one member that independent cameras could be used in places with no coverage, until a new CCTV system with increased capacity was sourced and installed, at which point they could be linked up to this new system. Pamela Donnelly assured the Committee that she was able to contribute to the process for sourcing a new CCTV system and that the project team are fully aware of the community safety aspect of using CCTV, the service provided to the Police, and the anxiety in local communities. She agreed to raise the Committee's points and suggestions with the project team, such as the potential for short-term use of stand-alone cameras to augment the existing network. A response would then be provided to the Committee.

A Committee member sought assurance that the Council was working with shops selling alcohol for offsite consumption in order to tackle street drinking and be proactive in addressing the sale of alcohol to those identified as being vulnerable to this issue. Pamela Donnelly confirmed that the Town Centre Partnership were focused on reminding shops of their statutory duties, working with the licensing officer at the Community Safety Hub in the Police Station. Mel Rundle provided further detail and explained the ongoing work on this issue, intervening where individuals have been issued with Community Protection Warnings or Notices relating to street drinking. When these are issued, details of the individuals can be provided to licenced premises, who can be asked to refuse sale to those individuals and avoid enabling criminal behaviour. Pamela Donnelly informed the Committee that Mel Rundle now had management responsibility for community safety and licensing issues, which would help ensure a joined up approach was taken.

Regarding the potential for street lights to be left on throughout the night in problem areas, a Committee member noted that Essex County Council had indicated that they would consider any requests to do this from the Police. They then questioned whether requests could be made for this in areas identified as being likely sites for criminal or antisocial behaviour. A member of the Committee further asked what plans were being made to tackle the idea that Colchester is not safe during the night. Pamela Donnelly agreed that it was not true that Colchester was not safe after dark. Despite a rise in violent crime, Colchester is still a safe place to live and work, when compared to other places. The fear of crime needed to be addressed, coming from perceptions, press and high-profile incidents. It was important for the work addressing crime to be publicised and for facts to counter perceptions, stressing the work and investment involved. Joint communications were carried out between the Borough Council and the Police to give clear messages

Superintendent Tom Simons explained that the Police need to demonstrate a clear link between lights being off and an increase in crime/antisocial behaviour, and that this could not be done at the present time. Practical benefits of keeping lights on could not currently be proved for areas such as the Dutch Quarter.

Superintendent Tom Simons noted that some of the increase in violent crime figures was attributable to improvements in recording practices, with no identified link to the night time economy, which was really well-managed in Colchester. A small group of individuals who target the vulnerable has been identified, but Colchester is still a safe place in general. Reassurance on this should be given to improve confidence in public safety.

The Committee raised the issue highlighted the role played by social media in shaping public perceptions and increasing the perception that levels of crime are higher than they are.

One member of the Committee requested details of what the County Council was doing to address the issue of County Lines, what the Borough Council was doing in co-operation with the County, and whether more could be done. Pamela Donnelly confirmed that the Borough Council had a role to play in safeguarding residents. Officers of Colchester Borough Council and Colchester Borough Homes were often in a good position to identify where concerns should be raised, including when working in cooperation with members of other organisations in the Partnership.

Superintendent Tom Simons briefed the Committee on current County Lines issues and their causes. Further improvement in cooperation between partner organisations is being sought. Essex Police have invested resources in community policing and in centralised programmes, such as the Raptor Teams targeting County Lines, with a Team based in Colchester. Cross-border working is conducted with other constabularies and social care teams outside of Essex. Technology is providing additional enforcement tools and options. The increase in County Lines drug supply has been driven by the market but the Superintendent gave assurance that, where issues are identified, the Police can act effectively.

In response to questions raised by a Committee member regarding instances of begging in Colchester, Inspector Jonathan Evans detailed the process to be followed in addressing those identified as carrying out such activity in breach of the Public Spaces Protection Order. This commences with advising the individual of the breach, issuing a Community Protection Warning, then escalating to a Community Protection Notice, if necessary. The Police rely on community support through reporting incidents and supplying evidence. These are vital for prosecutions to then succeed. The Committee stressed that reporting of most incidents should not be via 999 or 111. Inspector Evans agreed and detailed some of the ways in which reports can be made online and to the Police Station or to the Council's Zone Teams. Superintendent Tom Simons praised the provisions made in Colchester to address aggressive begging. Effective Police partnership with community safety teams helps them to address residents' concerns.

The negative perceptions felt by some members of the public about community safety in Colchester were highlighted by a Committee member, who encouraged the Police to look at further ways for their work to be publicised to address such perceptions and increase confidence. Inspector Jonathan Evans detailed some of the work being done to communicate their efforts, including via engagement with communities and community safety teams. There is a focus on listening to concerns and then giving reassurance to the public. Community policing teams are at the fore of this work. The public communication of Sgt. Martin Willsher and the local community policing teams was praised by a Committee Member who advised that this should be further built upon.

The Council and Police officers in attendance were asked for details about outreach work being carried out with schools, for an update on the progress of efforts to reduce littering (using Artemis Security patrols empowered to issue fines), and for information on how Team 10 compared with past use of Police Community Support Officers (PCSOs).

Responding, Pamela Donnelly confirmed that Chief Inspector Kane welcomed the advice and knowledge which councillors could provide in approaching outreach work in schools. This would be taken forward by Inspector Jonathan Evans.

Regarding the use of Artemis Security, Pamela Donnelly told the Committee that she would ensure that an update would be provided to members following the meeting.

Superintendent Tom Simons addressed the question about Team 10, explaining that Essex Police had in the past experienced funding cuts which had reduced front-line staff. Essex Police now had greater flexibility which has allowed for the increase in front-line officers. Most new funding is being targeted at community policing, public-facing roles and communication with the public. Sgt. Martin Willsher affirmed his confidence in the work of Team 10 and explained that there were two PCSOs on the team, with a further three (funded by Colchester Borough Council) soon to finish their training. In reply to follow-up questions from a Committee Member regarding the two-year Council funding for these PCSOs, Pamela Donnelly explained that the two-year funding had been set due to the potential for change in Council administration and direction limiting longer-term funding commitments, but that the Police required some certainty as to the Borough Council's commitment to the funding. Decisions regarding future budget decisions would need to be made by the Council early in the next municipal year. The Police investment in local policing is likely to influence these decisions.

The police officers present were asked by a Committee member whether information sharing by individuals and community groups, sometimes on social media, was helpful to

the Police. Inspector Jonathan Evans confirmed that evidence had been found that Neighbourhood Watch groups do seem to reduce crime levels where they operate, so these are encouraged. Pamela Donnelly praised the work of the Colchester Neighbourhood Watch Coordinator. There has been a rapid growth in Neighbourhood Watch schemes in Colchester. Inspector Jonathan Evans detailed plans to increase communications with these Schemes.

A question was asked regarding potential ways to expand the roles of the Ambulance and Fire Services in community safety. Pamela Donnelly informed the Committee that the Chief Executive of Colchester Borough Council had recently had meetings with the new Chief Fire Officer, Jo Turton, and that the Council had given significant input into the new Fire Plan and was participating in ongoing Fire Service projects. Pamela extended an invitation to the Michelle Behn of the Essex Ambulance Service to participate in future Community Safety Partnership meetings. Greg Keys of Essex County Fire and Rescue Service was invited to comment. He explained that the Fire Service was updating its approach to community safety and engagement, focused on station-based delivery within communities. Specialist staff are available to help conduct outreach work and messaging on safety, including work on home safety and efforts to achieve casualty reduction. This new approach is due to commence in April 2019, and the Fire Service was open to suggestions for new engagement opportunities.

A member of the Committee raised reports that Essex County Council were to commit additional funds to front-line services, including £250k for addressing homelessness/rough sleeping and asked if some of this would be assigned to Colchester. Pamela Donnelly hoped that this would be the case and highlighted the Borough's success in securing high levels of funding, to address this issue, from the Ministry of Housing, Communities and Local Government. She noted that the Ministry considered Colchester to be a flagship borough due to the success that has been achieved in tackling homelessness here. A team of Borough Council officers are tasked with identifying and bidding for funding, and an update would be provided to the Committee on this work.

In summary, Pamela Donnelly expressed her optimism for future work to further address community safety in Colchester Borough and highlighted the hard work and positive developments within the Community Safety Partnership over the last six months, and the shared vision held between the partner organisations. Superintendent Tom Simons echoed this and praised the Borough for its investment, planning and development of new approaches, supplemented by Police investment.

1. Executive Summary

- 1.1. This report provides the Crime and Disorder Committee with the opportunity to review the work of the Safer Colchester Partnership (SCP) during the period September 2018 to September 2019. Included within the report is background information and an explanation of the role of the Safer Colchester Partnership, work undertaken by the Partnership during September 2018 to September 2019 and the priorities for 2018/19.
- 1.2. The key stakeholders of the SCP are the relevant Borough Council Portfolio Holder and Executive Director, Colchester District Commander (North Local Policing Area) Essex Police and senior representatives from Health, National Probation Service, Essex Community Rehabilitation Company, Essex County Council, Essex Fire and Rescue and Colchester Borough Homes. Representatives from some of these organisations will be present to provide further details to Committee members and to answer any questions that they may have.

2. Action Required

2.1. To invite the Crime and Disorder Committee to scrutinise the work of the Safer Colchester Partnership (SCP).

3. Reason for Scrutiny

- 3.1. Under the Crime and Disorder (Overview and Scrutiny) Regulations 2009 the Committee is required to meet once a year to review the work and progress of the Safer Colchester Partnership in connection with the discharge by the responsible authorities of their statutory crime and disorder reduction functions.
- 3.2. In addition, the Committee also requested (at the 11 September 2018 meeting) that it would be useful to hold an additional meeting of the Crime and Disorder Committee towards the end of the municipal year to review the plans for the Safer Colchester Partnership for 2019-20; therefore, an interim meeting took place on 26 February 2019.

4. Background Information

4.1. The Crime and Disorder Act 1998 sets out statutory requirements for local agencies to work together to tackle crime in their local area. Partners involved in this work are known as 'Responsible Authorities'.

- 4.2. The SCP was set up in order to deliver this statutory duty and includes the following partners: (statutory) Colchester Borough Council (CBC), Essex Police, Health/Clinical Commissioning Group (CCG), National Probation Service (NPS), Essex Community Rehabilitation Company (CRC), Essex County Council (ECC), Essex Fire and Rescue Service (ECFRS) and non-statutory partners include Colchester Borough Homes (CBH), University of Essex, Community 360 and Colchester Garrison.
- 4.3. In addition, since September 2018, new members to the SCP include: East of England Ambulance Service, North Essex Children's and Families Service, North Essex Adult Social Care and Essex Youth Offending Service (all representing ECC) and Colchester Business Improvement District (BID).
- 4.4. There are many areas where the work of agencies overlaps, and it is more effective to work in partnership to address issues. Also, more effective data sharing between agencies enables partners to target resources to where they are needed most.
- 4.5. The SCP has a statutory duty to carry out an annual assessment of crime called a Strategic Assessment of Crime. This involves analysing data on the frequency, location and types of crime (over the period 1 October 30 September) in order to identify patterns and trends. The CBC Community Safety Team, alongside the Essex Police Intelligence Analyst, lead on the delivery of this report and, once completed, it is shared amongst SCP partners and used to develop a shared Annual Partnership Plan which prioritises the key local issues and outlines actions to address them. The SCP then monitors this Annual Plan throughout the year (1 April 31 March), reviewing and refocusing activity as necessary to effectively tackle the issues.

5. The Partnership's work during 2018 – 2019

- 5.1. The SCP Annual Partnership Plan (APP) for April 2018 March 2019 focussed on four Key Priorities (KPs):
 - Protect vulnerable people by increasing the awareness and reporting of Hidden Harms
 - Address Gangs and County Lines by developing intelligence and awareness to support those vulnerable to exploitation
 - Reduce the occurrence of violent crime including sexual offences and weapons offences
 - Tackle incidents of high harm, repeat Anti-Social Behaviour (ASB) and Hate Crime
- 5.2. The SCP Annual Report Summary which details the specific work and projects undertaken to address these themes is attached as Appendix A, however an example 'project/highlight' from each of the 4 KPs can be found below.
- 5.3. KP1: The Virtual Crew (Year 6 pupils) pilot was launched during July 2018 (replacing Crucial Crew, which had become too resource-intensive and no longer cost-effective). A series of computer stories designed to mirror the real safety workshops for schoolchildren were developed by 14 students at Colchester Institute. Each of the game scenarios was designed in partnership with The Community Safety Team, with input from Essex Police, Colchester Borough Homes ASB Team and the Children's Society. 1,006 pupils registered for Virtual Crew from

34 primary schools. 13 schools declined to take part, however six of these have confirmed they will take part in July 2019.

- 5.4. KP2: Training relating to Mate Crime and Cuckooing was commissioned by SCP and delivered to 81 delegates in October 2018. The training focused on how a vulnerable adult exposed to 'mate crime' can quickly escalate into becoming the victim of 'cuckooing' and is designed to enable employees with an understanding of the issues relating to this activity, by examining the types of crimes perpetrated, signs and indicators of this abuse, identifying individuals/groups who may be at risk and identifying actions that can be taken to safeguard individuals.
- 5.5. KP3: Operation Diss, a bespoke Police operation to tackle ASB/knife crime and aggressive begging within Colchester Town Centre, was undertaken in August 2018, September 2018, January and February 2019. The Operation is aimed at ensuring that the community, including local businesses, enjoy the Town Centre without the fear of being intimidated or threatened with violence. 14 arrests have been made for recent burglaries within the Town Centre. Three individuals have been remanded.
- 5.6. KP4: The TCAP (Town Centre Action Plan) was initiated August 2018 as a result of increased complaints of aggressive begging, street drinking, drug use and associated ASB. The TCAP consists of a package of enforcement, support, awareness and education and is supported by a weekly partner meeting at which Police, Colchester Borough Council, Colchester Borough Homes, Essex CRC and National Probation Service meet to confidentially discuss those individuals who are causing harm, distress or harassment to the public, and actions agreed. Alongside the individuals, 'hotspot' locations experiencing anti-social behaviour and crime are also discussed and a course of action to tackle those areas is agreed. These meetings are proving to be invaluable in terms of partnership working and having a full picture of activity in the Town Centre.

In the period 6 August - 26 April 2019:

- 58 CPWs issued for ASB/Begging/Street Drinking.
- 15 CPNs issued for ASB/Begging/Street Drinking.
- 3 CBOs (Criminal Behaviour Orders) issued relating to ASB/Begging/Street Drinking.
- 4 CBO applications made, one of which has been issued by the courts and has resulted in a custodial sentence due to breaching this order.
- In the same period 11 FPNs issued for ASB/Street Drinking in contravention of the Public Space Protection Orders (PSPOs)

6. Plans for the Partnership's work during 2019 – 2020

6.1. The key priorities for 2019 - 2020 are:

KP1 - Tackling Gangs & County Lines, focussing on keeping drugs and weapons out of the Community

The Safer Colchester Partnership will to continue to develop the intelligence and awareness picture of this escalating criminality, especially focussing on County Lines. The Safer Colchester Partnership will strive to provide appropriate safeguarding and support to those vulnerable to this type of drug-related exploitation (cuckooing/drug running etc.); with a further aim to assist in the disruption of drug-related activities within the community.

<u>KP2 - Driving down Anti-Social Behaviour and Violent Crime in public places</u> The Safer Colchester Partnership will use all available resources and legislation, including utilising the four standing Public Space Protection Orders (PSPOs), to tackle ASB and violent crime within the District. Reductions in these areas will bring reassurance to residents regarding their personal safety and will assist in driving down crime rates for the area. ASB affects families and communities and by addressing this type of behaviour and conduct we can help improve the community's quality of life.

<u>KP3 - Increase confidence in identifying and reporting Hidden Harms</u> The Safer Colchester Partnership will aim to increase the understanding and awareness, of both the general public and front-line practitioners, of the Hidden Harms our communities face. Encouraging those who are affected by these harms to engage with the Partnership or relevant agencies/charities to seek help and support, with an emphasis on Domestic Abuse and Hate Crime as identified by the risk matrix.

- 6.2. The Annual Partnership Plan for 2019-20 is attached as Appendix B
- 6.3. Safer Rural Communities Toolkit
 - There will be a focus on helping Rural Communities within Colchester to tackle crime and disorder. CBC (supported by the SCP) are launching a Rural Communities Toolkit in October 2019 (as part of Essex Police Rural Crime Awareness Week). The Toolkit provides ideas, information and resources to help communities make their neighbourhoods a better place to live. The Toolkit is further supported with a CBC Rural Communities fund of £30,000, for which rural communities can bid for funds of up to £1,000 per project.
- 6.4. There will continue to be a focus on addressing hidden harms, including launching of the Observers Scheme (a scheme to upskill existing frontline staff to spot the signs of hidden harms and have a reporting mechanism to report concerns) and delivery of a Hidden Harms event to raise awareness with professionals.

7. Changes during the year

- 7.1. Following significant investment from CBC, Essex Police and CBH, Team 10 (launched in January 2019), has brought almost £600k* of additional resources to address issues of crime and public safety in the Borough and increase public confidence that issues are being addressed.
- 7.2. Changes to Colchester Police included Chief Inspector Rob Huddleston taking over as the Colchester District Commander and Inspector Jonathan Evans taking over as Community Policing Team Inspector.
- 7.3. Colchester Police have also seen an increase of four Police Officers in July, enabling the Town Centre Team to grow and ensure a 24-hour coverage of the Town Centre, delivered over three shift patterns. Team 10 was changed to Town Proactive Team to reflect the expansion of resources.

8. The Police, Fire and Crime Commissioner (PFCC)

- 8.1. Cllr Michael Lilley continues to be a member of the Police, Fire and Crime Panel throughout the year, which is the body set up to scrutinise the work of the PFCC. He will be at the meeting to provide an update on the work of the panel and to answer any questions.
- 8.2. The current PFCC, Roger Hirst, held an engagement event in Colchester on 11 October 2018 and members of the public, Councillors and officers attended to hear about the role and work of the PFCC and ask to ask him questions about crime and disorder.
- 8.3. Essex's first ever Fire and Rescue Plan was supported and approved by members of the Police, Fire and Crime Panel in February 2019. The Plan that sets out the vision and priorities for the delivery of fire and rescue services in Essex and will run from 2019 to 2024. The Plan will be the basis on which Mr Hirst holds Essex County Fire and Rescue Service to account for its performance. The document mirrors the Police and Crime Plan which sets the priorities for policing in Essex
- 8.4. The annual PFCC event took place at Colchester Community Stadium on 7 June 2019, with the theme of the event being 'Delivering through Partnerships'. Guests attending were offered the opportunity to take part in two of the six workshops that were on offer, including ECFRS FireBreak, Essex Police Raptor Team Gangs Operations, Colchester United 'Unite Our Communities' Taster, Southend Combat Academy sessions, AlterEgo Theatre Workshop (gangs/county lines/exploitation) and Designing Out Crime.

9. Equality, Diversity and Human Rights implications

9.1. No specific Equality and Diversity implications.

10. Strategic Plan References

10.1 This work contributes to the Council's Strategic Plan 2018 - 2021 by working in partnership to tackle crime issues and anti-social behaviour. Specific links to 'Responsibility' (Educate residents who behave antisocially about the impact of their behaviour) and 'Wellbeing' (Work with Essex Police and partners in the SCP to make Colchester an even safer place).

11. Consultation

11.1. The Strategic Assessment of Crime 2018-19 was completed in May 2019 and input from partners has informed the partnership plan for the 2019-2020 period.

12. Publicity Considerations

12.1. All publicity aims to achieve a positive reflection of the work of the Safer Colchester Partnership. There is a dedicated website, providing information and advice for residents and members of the public – <u>www.safercolchester.co.uk</u>

13. Financial implications

13.1. It is expected that funding for the Partnership's work will continue to be reduced. Therefore, the Partnership will consider the financial sustainability of any project work it undertakes.

14. Community Safety Implications

14.1. The community safety implications are the subject of this report.

Appendix A - SCP Annual Report Summary 2018-2019

The Crime and Disorder Act 1998 requires the Community Safety Partnerships to complete an annual partnership plan. The legislation also places a joint responsibility upon specific agencies to work together to protect the local community from crime, and to help people feel safer.

The Safer Colchester Partnership consists of representatives from the following statutory authorities:

- * Colchester Borough Council (CBC)
- * Essex Police
- * Essex County Fire and Rescue Service
- * Essex Community Rehabilitation Company
- * Essex County Council
- * National Probation Service
- * Clinical Commissioning Group (NHS)

Safer Colchester Partnership also consists of non-statutory representatives from:

- * Colchester Garrison
- * University of Essex
- * Community 360
- * Colchester Borough Homes
- * BID

The Partnership identified four specific priorities for 2018/19 following an assessment of crime and disorder, and consultation with various agencies.

The strategic key priorities for 2018-2019 are:



These priorities formed the basis of the Safer Colchester Partnership (SCP) action plan and other activities during the year. This report provides an overview of projects and initiatives that have contributed towards achieving the Annual Partnership Plan targets and meeting the objectives of the Crime and Fire plan.

PRIORITY ONE - PROTECT VULNERABLE PEOPLE BY INCREASING THE AWARENESS AND REPORTING OF HIDDEN HARMS

THE PARTNERSHIP WILL AIM TO INCREASE THE UNDERSTANDING AND AWARENESS, TO BOTH THE GENERAL PUBLIC AND PRACTITIONERS, OF THE HIDDEN HARMS OUR COMMUNITIES FACE. ENCOURAGING THOSE CHILDREN AND ADULTS WHO ARE AFFECTED BY THESE HARMS TO ENGAGE WITH THE PARTNERSHIP OR RELEVANT AGENCIES/CHARITIES TO SEEK HELP AND SUPPORT.

Virtual Crew (Year 6 pupils) pilot was launched during July 2018, following consultation with the secondary schools, along with agreement from strategic partners, a pilot of "Virtual Crew" was developed to replace Crucial Crew. A series of computer stories designed to mirror the real safety workshops for schoolchildren were developed by 14 students at Colchester Institute. Each of the game scenarios was designed in partnership with The Community Safety Team, with input from Essex Police, Colchester Borough Homes ASB Team and the Children's Society. 1006 pupils registered for Virtual Crew from 34 primary schools. 13 schools declined to take part, however 6 of these have confirmed they will take part in 2019. 15 schools showed initial interest but didn't register.

Observers is a programme which focuses on groups and individuals who are employed or involved in activities which, may allow them to more readily 'Observe' vulnerable residents or criminal activities in targeted locations. The list of potential "Observers" is comprehensive, but it appears local authorities are directly or indirectly responsible for about a third of the activities.

Crime types are becoming more diverse and in many cases the signs of serious crime and vulnerability are not easily observable. This programme would be directed at those who can more readily observe possible or actual criminal activities and be aware of potential at risk residents or situations. Awareness sessions and an E-learning package will be available for all CBC/CBH employees.

Gangsline School & College Assemblies are a one-hour presentation primarily for students aged 9-18 years old (Year 5 to Sixth Form/College) designed to help raise awareness and build resilience against the negative influences of street gang culture and will address several topics. The presentation aims to build resilience and raise awareness around the dangers of gang culture. Provide a greater understanding of the myths surrounding gang culture. Give a greater understanding of the nature of peer groups which are characterised by violence. Illustrate the impact of gangs in their communities and offer opportunities for young people to confide in ex-gang members.

Behind Closed Doors Conference was delivered to raise awareness of Child Exploitation, Domestic Servitude and Forced Marriage. It was a very successful day, with 93% of attendees saying it was relevant to their role and 94% were satisfied with the conference. 48 people attended from a broad range of communities and backgrounds. Four empowering female speakers from a range of backgrounds spoke about the work of social care with BAME families, FGM, modern slavery and forced marriage, and the building of an empowerment project from lived experience. Two of the speakers demonstrated as leaders and trainers that as survivors of abuse they were strong, successful and powerful women who were using their experience to empower others.

PRIORITY TWO - ADDRESS GANGS AND COUNTY LINES BY DEVELOPING INTELLIGENCE AND AWARENESS TO SUPPORT THOSE VULNERABLE TO EXPLOITATION

THE PARTNERSHIP WILL TO CONTINUE TO DEVELOP THE INTELLIGENCE AND AWARENESS OF THIS ESCALATING AREA OF CRIMINALITY, ESPECIALLY FOCUSSING ON COUNTY LINES. TO BEST TACKLE THIS ISSUE THE PARTNERSHIP WILL STRIVE TO PROVIDE APPROPRIATE SAFEGUARDING AND SUPPORT TO CHILDREN AND ADULTS THAT ARE VULNERABLE TO THIS TYPE OF DRUG-RELATED EXPLOITATION (CUCKOOING/DRUG RUNNING/TRAFFICKING OF DRUGS ETC.); WITH A FURTHER AIM TO ASSIST IN THE DISRUPTION OF DRUG-RELATED ACTIVITIES WITHIN THE COMMUNITY.

In March 2018, Crimestoppers launched a National campaign to raise awareness about the issue of **County Lines** while encouraging people to pick up the phone and report any suspicious activity in their area. An advan toured certain areas giving people more information on how they can play their part in helping to tackle this issue. In addition, a social media campaign was launched by the charity to raise awareness of the crime.

81 delegates, over 4 sessions received **Mate Crime / Cuckooing Training** in October. The training focused on how a vulnerable adult exposed to 'mate crime' can quickly escalate into becoming the victim of cuckooing. It's designed to enable employees with an understanding of the issues relating to Mate crime and Cuckooing, by examining the types of crimes perpetrated, signs and indicators of this abuse, and identify individuals /groups who may be at risk and identify actions that can be taken to safeguard individuals.

Delivered on the 8th October 2018 to delegates from; Colchester Academy, Colchester Royal Grammar School, Colchester County High for Girls, Colchester Institute, Colchester Institute, Colchester Safer Partnership, Iceni Academy, Thomas Lord Audley, NEECA Colchester Campus, Old Heath Community Primary School, St Benedict's Catholic College, The Colne Community School and College, The Gilbert School, The Sixth Form College, The Stanway School, Thurstable School, St Helena School. The aims of the **Gangsline Professional Training** were to understand the context and merging themes around modern gangs, be able to identify children or young people who may be groomed and how to develop more effective intervention pathways for young persons at risk.

Venues within Colchester were provided with surface wipe **drug testing kits**, allow on-site detection of drug residues to be detected in under 5 minutes. The 10 drug multi-panel surface wipe kit screens environments for 10 individual drug groups and can also be used to test powders, crushed tablets and plant materials. Venues can Use to screen toilets, the bar and outside areas where they suspect drugs may have been used. If the drug is still present, even in billionths of a gram amounts, these tests will give a positive result.

PRIORITY THREE - REDUCE THE OCCURRENCE OF VIOLENT CRIME INCLUDING SEXUAL OFFENCES AND WEAPONS OFFENCES.

THE PARTNERSHIP WILL AIM TO PREVENT VIOLENT CRIME USING AN INTEGRATED APPROACH TO ADDRESS THE ROOT CAUSES AND DRIVERS FOR CRIME IN CONJUNCTION WITH LAW ENFORCEMENT AND CRIMINAL JUSTICE SYSTEMS. WORKING COLLABORATIVELY WITH ASSOCIATES TO INVESTIGATE AND DELIVER A NUMBER OF PROGRAMMES TO PREVENT AND REDUCE VIOLENCE, TO ENCOURAGE CHILDREN AND ADULTS TO MAKE POSITIVE LIFE CHOICES FOR THEMSELVES AND OFFERING POSITIVE ALTERNATIVES TO OFFENDING THEIR FAMILIES AND THEIR COMMUNITIES.

Street Weeks, a community initiative involving Essex Police and its partners through the Safer Colchester Partnership, launched A partnership project tackling criminality and anti-social behaviour while engaging with Colchester's most vulnerable people. The week will see officers deal with anti-social behaviour through visible policing while tackling drug activity, domestic abuse and child neglect by carrying out door-to-door enquiries and spot checks within neighborhoods. In June 2018, Colchester held its 3rd Street Weeks. Colleagues from the North Essex Parking Partnership, the Neighbourhood and Dog Watch team, Community 360, Guinness Housing Association, Colchester Borough Homes, Essex Young People's Drug and Alcohol Services, the DVLA, Essex County Fire and Rescue Service, Crimestoppers and One Support, were involved alongside Active Citizens, Licensing Team, Special Officers and Roads Policing Unit.

Saturday 17th November saw over 200 people standing together in Colchester High Street on the **Reclaim the Night Awareness Walk**. The march gives women a voice and a chance to reclaim the streets at night on a safe and empowering event. We aim to put the issue of our safety on the agenda for this night and every day. The Reclaim the Night marches started in the UK on the 12th November 1977, when torchlit marches were held across England in Leeds, York, Bristol, Manchester, Newcastle, Brighton and London.

12 Acid Attack Kits were installed in 12 NTE venues, providing users of the NTE reassurance that the busier venues have such kits available. The kits are in essence a portable box with a number of items inside including a 5-litre water bottle which could be utilised in response to an attack at or near a venue. Whilst the generic term "acid" has been used other noxious or corrosive substances could also be included in the term.

PRIORITY FOUR - TACKLE INCIDENTS OF HIGH HARM, REPEAT ANTI-SOCIAL BEHAVIOUR (ASB) AND HATE CRIME

THE PARTNERSHIP WILL USE ALL AVAILABLE RESOURCES AND LEGISLATION, INCLUDING UTILISING PUBLIC SPACE PROTECTION ORDERS (PSPOS), TO TACKLE ASB AND VIOLENT CRIME WITHIN THE BOROUGH. IN COLLABORATION WITH PARTNERS WE WILL REDUCE THE ROLE OF ALCOHOL AND DRUGS IN FUELLING CRIME AND ASB. HATE CRIME AND ASB AFFECTS BOTH CHILDREN, ADULTS, FAMILIES AND COMMUNITIES AND BY ADDRESSING THIS TYPE OF BEHAVIOUR AND CONDUCT WE CAN HELP IMPROVE THE COMMUNITY QUALITY OF LIFE. COMMUNITIES NEED TO UNDERSTAND HOW HATE CRIME AND ASB CAN IMPACT ON AN INDIVIDUAL AND KNOW WHAT ACTIONS THEY CAN TAKE WHETHER THEY ARE THE VICTIM OR AN OBSERVER, WE WILL BUILD RESILIENT COMMUNITIES TO RAISE AWARENESS OF HATE CRIME AND ASB. REDUCTIONS IN THESE AREAS WILL BRING REASSURANCE TO RESIDENTS REGARDING THEIR PERSONAL SAFETY AND WILL ASSIST IN REDUCING CRIME IN THE AREA.

In February 2019 CBC Community Activities with ECFRS were successful in gaining funding from CBH for the Colchester Youth Project. Ten youths attended a 'Fire Inspire Course' run by the Fire Service. Aimed at youth's 13-17yrs that have already passed an initial week's Firebreak Course can now go on and progress even further. Inspire includes preparing young people for employment and preparing for interviews, CV preparation and the importance of gaining employment. Alcohol and substance misuse awareness sessions are included along with other important topics. The course also encourages Community engagement and the possibilities of volunteering, fitness' as modern healthier lifestyle with good nutritional choices for life and building self-esteem and confidence and at the end of the programme each student will gain an accreditation from the Assessment and Qualifications Alliance as well as personal testimonials and certificates relating to first aid, fire safety awareness and water safety

Following public consultation, CBC introduced three **Public Space Protection Orders** (PSPO) within Colchester Town Car Parks, East Bay and the Town Centre. The orders were introduced following an increase in ASB within these areas.

Initiated August 2018 as a result of increased complaints and issues over the last 12 to 18 months, a **Town Centre action plan** was created to agree enforcement action, alongside support for individuals within the Town Centre that persistently cause ASB or that rough sleep or homeless. Most recently, an audit by CBH Outreach identified a total of 3 rough sleepers in the Colchester Town Centre. This has been reduced from 12 at the start of the initiative. Every week a partnership meeting takes place to talk through activity the previous week and set actions as a result. A Strategic Group meets every quarter to discuss progress and direction

CBC Community Safety team worked in partnership with Essex Youth Services and the University of Essex to deliver the **Youth ASB Hotspot Pilot**. The aims of the initiative were to assist in the development of interventions to reduce ASB, improve the life chances of marginal young people, make better use of community assets and promote inclusive economic growth and prosperity. ASB carries a range of implications for perpetrators and victims including the effects of criminal damage, social isolation, fear, deteriorating built environment, isolating of young people in their own communities, potential exclusion from education, training, skills and job opportunities. Evaluation data indicates that the detached youth workers engaged with 41 individual children and young people, some on more than one occasion, some already known to them through their routine work, who were deemed to

present a potential risk of ASB or related activity. Most of their engagement was focused on the Colchester town Centre area and on older youths (7 were aged 15-16; 25 were aged 17-19; 4 were aged 20-25). A further 5 children aged 11-12 were engaged in the New Town area.

Fire & Crime Plan Priorities 2016 – 2020

The Police and Crime Plan sets out the policing priorities and aims for keeping Essex safe. It brings together police, partners and the people of Essex to build safe and secure communities, thereby promoting public confidence in the police and ensuring that victims are satisfied with the service and support they receive. The commitments set out in the plan build on existing partnerships and seek to develop them in new and ambitious ways. These include greater collaboration between police and fire and closer working with local councils, community safety partnerships, and the voluntary, community and health sectors

- 1) More Local, visible and accessible policing
- 2) Crack down on anti-social behaviour
- 3) Breaking the cycle of domestic abuse
- 4) Reverse the trend in serious violence
- 5) Tackle gangs and organised crime
- 6) Protecting children and vulnerable people
- 7) Improve safety on our roads

Town Centre Action Plan Notable Achievements

During the period January 2019 - June 2019, positive partnership activity has resulted in the following:

- Patrols and activity in Town Centre by both Police and CBC Zone Teams an average of 200 hours per week
- Joint enforcement action including the issue of 31 Community Protection Warnings (CPWs), 9 Community Protection Notices (CPNs) and 5 Fixed Penalty Notices (FPNs)
- 35 Arrests relating to the Town Centre (including ASB/Burglary/Graffiti)
- Two Criminal Behaviour Orders (CBOs) issued.
- One Custodial Sentence for breach of Criminal Behaviour Orders (CBO)
- One Custodial Sentence for breach of Antisocial Behaviour Order (ASBO)
- Reduction of high-priority individuals (those causing the most nuisance, harm and distress) from 14 in August 2018 to 0 in June 2019
- 14 CBC Recycling Units were installed in Town Centre and Castle Park on 14 February
- Positive partnership working to tackle the hotspot locations, resulting in a reduction of 10 to 7
- Updated Town Centre PSPO signage to provide clear guidance of unacceptable behaviour
- 3 new CBC funded PCSOs completed training and started in Team 10 in March 2019
- Successful drugs warrant executed in Dutch Quarter (Class A)
- Test Purchase operation ran for OP SCEPTRE 6 retailers tested. 3 failed and sold knife/bladed articles to under 18s.
- CBC 'Gum Drop' campaign launched 14 January 2019 35 bins were installed around the Town Centre
- Positive partnership working to tackle the hotspot locations, resulting in a reduction of 13 to 6
